Wayne Adams and called the meeting to order. Also attending the meeting were the new principal of South Houston High School, Jennifer Stewart, Al Carter and Genia Ripley Mahaffey.

Upon motion made by Herman Munster and seconded by Jose Rosales, the minutes of the meeting of November 11, 2025 were unanimously approved.

Bruce Summers presented the Treasurer’s report with data through the end of 2025. Upon motion made by Herman Williams and seconded by Herman Munster, the financial report was approved.

On behalf of the nominating committee, Herman Williams announced that Johnny Fusilier had submitted is resignation due to conflicts with his duties on the Pasadena City Council. Gayle Holder also announced her resignation from the Board. The Nominating Committee recommended adding Genia Ripley Mahaffey to the Board. The Board discussed options to fill the other open position on the Board. Audra Taylor was mentioned as a possible candidate as she is an SHHS Alumni and current faculty at the school. The Board needs Audra to complete the Candidate application for consideration.

Wayne Adams announced that the Pasadena ISD Athletic Hall of Fame banquet will be held on Thursday, April 9th at Phillips Field House with Jim “Mattress Mack” McIngvale as the keynote speaker.

The Board then discussed the scheduling of the Annual Meeting in April and selected Thursday, April 23rd as the date for that meeting. In preparation for the annual meeting, the Hall of Honor nominating committee will be meeting on January 29, 2026 at the school at 3:00 pm to review candidates and make selections for 2026 inductees.

The Board then discussed that South Houston’s football team might be moved to a 5A classification for 2026 which would mean a different class of football competition for the 2026 football season. Homecoming would not be scheduled until the classification assignment has been determined and the football schedule determine.

Principal Stewart shared with the Board that she had met with Dr. William Redwine regarding his generous offer to provide a scholarship to a student at SHHS. She and Dr. Redwine have developed a process to follow the careers of a group of student who show promise and would be candidates for scholarship. Principal Stewart also shared announcements for outstanding student achievements. Principal Stewart also shared that the entrance to the school would be updated with a door film to reduce visibility into the school.

Al Carter mentioned that he still has several class panoramas that need to be mounted but is in need of the mounting hardware which would cost about \$200-\$300.

Upon motion made by Ricki Willoughby and seconded by Jose Rosales, the Board unanimously voted to adjourn the meeting.
