Authorization of Special Revenue Grant Fund (604) (DFA # 21800) budget increase

**WHEREAS**, the Board of Commissioners of Union County meeting in regular session on June 20, 2023 did propose to make budget adjustments; and

**WHEREAS**, the County of Union does, through Budget Resolution 2023-46 ask that authorization for the budgetary adjustments be granted, as summarized in the attachment; and


**WHEREAS**, the County of Union wishes to increase revenue and expenditures by ten thousand dollars (\$10,000) for the Summer Food Program received by the County. Expenditures will include temporary salaries and supplies for the program.

**NOW THEREFORE, BE IT RESOLVED** the Board of Commissioners of Union County does hereby approve the aforementioned budget adjustments and respectfully requests the authorization for the budgetary adjustments and revisions be granted by the Local Government Division of the Department of Finance and Administration of the State of New Mexico.


