HST Global, Inc. Files Current Report on Material Agreements: Acquisition of Amnion LLC Completed

HST Global, Inc. (OTC: HSTC) today filed a Current Report on Form 8-K with the U.S. Securities and Exchange Commission, reflecting the completion of a material definitive agreement under which HST Global acquired all membership interests of Amnion LLC.

Under the terms of the agreement, executed October 2, 2024, HST Global issued restricted common stock as consideration. Upon execution, 1,000,000 shares vested immediately. Additional shares will vest upon Amnion LLC achieving certain revenue milestones including 2,000,000 shares upon achieving \$250,000 in revenue within 12 months, and a further 2,000,000 shares upon reaching \$500,000 in revenue within 24 months.

As part of the acquisition, HST Global committed to advance \$150,000 in operational cash to support business continuity during the transition. The agreement also contemplates a potential \$1,000,000 investment in Amnion LLC within six months.

“We are pleased to formally announce the acquisition of Amnion LLC as an important step in expanding our business portfolio,” said Mike Field, President of HST Global. “This transaction strengthens our footprint and aligns with our strategic growth initiatives as we integrate Amnion’s operations into our existing infrastructure.”

Because of this acquisition, HST Global will likely experience a delayed filing of its Form 10-K to permit audit and consolidation of Amnion’s financials.
