# **Definition of a Community Group**

For the purposes of these Terms and Conditions, a **community group** refers to an organization that operates within a community to provide services, activities, or support that benefit the public or a specific group of individuals. **Pubs and registered clubs are excluded under this definition and are required to create a business account.** 

Each community group must have it's own 'Log In' and hold/provide the ABN of that organisation. This includes but is not limited to:

- Not-for-Profit Organizations: Entities that are established for purposes other than generating profit and whose surplus funds are reinvested into their mission or objectives. These organizations may focus on areas such as education, culture, health, social support, or environmental advocacy.
- Sporting Clubs: Organizations that facilitate participation in recreational or competitive sports. These may include local sports teams, fitness groups, or clubs that promote physical activity and community engagement.
- 3. **Charities**: Organizations registered under relevant legislation as charities or recognized as providing public benefit, often focusing on areas such as poverty alleviation, education, health care, or emergency relief.

A community group, as defined here, must operate with the primary goal of benefiting its members or the broader community and must not distribute profits or surplus funds to owners, shareholders, or private individuals.

These groups may be formally registered or informally structured but must align with the general principles of community service, inclusion, and support. Failure to meet these criteria may result in ineligibility for services or benefits provided under these Terms and Conditions.

### **Definition of a Business**

A **business** for the purposes of these Terms and Conditions refers to any entity, organization, or individual operating in Australia that is engaged in commercial, professional, or trade activities with the intention of generating profit. This includes, but is not limited to, sole traders,

partnerships, companies, trusts, and other legally recognized business structures. **Pubs and registered clubs are classified as Businesses and are required to create a business account.** 

To qualify as a business under these Terms and Conditions, the entity must be registered with the Australian Business Register (ABR) and hold a valid **Australian Business Number (ABN)**. By engaging with our services as a business, you confirm that you are duly registered, compliant with relevant Australian laws, and authorized to operate under an ABN.
