In addition to serving as your Vice President, I am honored to also serve as your Legislative Chair. I would like to provide you with an update on several key issues currently being addressed at the legislative level.

We are actively exploring whether there is interest within Congress to take the lead on addressing the disparity in annual cost-of-living adjustments (COLA) between CSRS and FERS retirees. For 2026, the CSRS COLA is set at 2.8%, while FERS retirees will receive only 2.0%. Because this difference is established by law, any change would require Congressional action. Such a change would involve significant cost to the government, making it a challenging and lengthy effort—however, so was the WEP/GPO fight, and that battle was ultimately won.




Health benefits remain another priority concern. Premiums continue to increase at a rate outpacing our cost-of-living adjustments, placing additional strain on retirement income. We are also pursuing efforts to have retiree health insurance premiums deducted from gross income before taxes—an option already available to active employees.

Your leadership team remains committed to keeping you informed and advocating to ensure that retiree benefits remain fair, protected, and reflective of the commitments made to all of us upon retirement.

As we enter the Christmas season, I wish you moments of peace, joy, and connection with family, friends, and loved ones. May God bless you in the year ahead.

As FSA employees we had good jobs with a generous benefit package. Our good fortune continued into retirement where we had access to a CSRS or FERS pension plan with some inflation protection, the opportunity to accumulate a robust TSP account with multiple investment options, and the chance for our FEHB plan with its government premium contribution to continue into retirement and even optionally supplement Medicare.

By the time you read this, you'll have made your year-end decisions regarding FEHB and Medicare. Having the opportunity to revise our coverages annually is another nice benefit we enjoy.

Because each year new people are reaching the mandatory Required Minimum Distribution (RMD) age, I will again briefly outline this requirement. As we near the year's end, some of us will be finalizing plans for RMDs from qualified accounts and annuities, where federal income taxes have been deferred.

The age at which you must start taking RMDs depends on your year of birth:

- **Before July 1, 1949:** You start taking RMDs at age 70½
- **On or after July 1, 1949:** You start taking RMDs at age 72
- **On or after January 1, 1951:** You start taking RMDs at age 73
- **On or after January 1, 1960:** You start taking RMDs at age 75

One of the popular RMD strategies for reducing taxes involves donating some amount to charity with a Qualified Charitable Distribution (QCD). This is especially fortunate as we enter the holiday season to be able to satisfy the RMD requirement and do some charitable-gift giving as well.

The IRS allows you to donate up to \$100,000 a year from an IRA without having to pay income tax. The QCD you withdraw will still count toward your RMD so you don't have to worry about a 50% tax penalty for failing to take distributions.

- Your qualified account custodian must arrange for the transfer of funds directly to an eligible charity. For example, per my request my custodian makes three of our QCDs to the food bank, our church, and a local land trust.
- The QCD reduces your taxable income even if you don't itemize deductions.

Also, as we begin to see our year-end investment reports it is a good time to consider if these investments are still in the best possible position for our current financial situation. This legislation restored Social Security benefits for millions of public servants.

Having served as SWA Exec, I can tell you that this historic legislation was the product and culmination of many years of tireless legislative work of RASCOE, NASCOE, and NARFE. It was a great win for so many retirees which saw back retroactive benefits paid in 2025.

Unfortunately, 2025 also was a very trying and stressful year out in our FSA county offices with many early retirement decisions being forced upon our FSA employees. If you did decide to retire in 2025 under DRP 1 and DRP 2 but have not joined RASCOE, I would encourage you to join the rowdy crew of RASCOE. Remember your first year of RASCOE dues are FREE and thereafter annual dues are \$25.00 and Associate dues are \$15.00. State RASCOE Associations may also charge a small state dues fee in addition to the RASCOE fee of \$25.00. 


