



Thrive the Matrix Life Coaching Code of Ethics & Terms of Use

Please review the [Code of Ethics \(COE\)](#) and [Terms of Use \(TOU\)](#) carefully, which represent a Life Coach / Client agreement for participation in Thrive the Matrix Life Coaching Services and review of associated content. You must agree to these COE and TOU.

If you do not agree with these COE or TOU, you should not request or employ the services of Thrive the Matrix (TtM) LLC, d/b/a Thrive the Matrix Life Coaching d/b/a TtM or view any digital or downloadable resources, or enter any online private forums operated by Thrive the Matrix (for any purpose), whether on the website hosted by Thrive the Matrix Life Coaching, www.thrivethematrix.com or a third-party website or online course platform, or facebook.com. All the above may be collectively referred to as “The Program” or for online courses, one-on-one or group Coaching, classes, programs, workshops, or training, this document may refer to “Interactions.”

If you do not agree with these TOU, you may not use the Program.

As used in this document and agreement, the term “Releases” is defined to include the following: (i) Thrive the Matrix (TtM) LLC, d/b/a Thrive the Matrix Life Coaching d/b/a TtM, its subsidiaries, affiliated companies, owners, members, managers, directors, officers, past and present employees, agents, Coaches, representatives, successors and assigns (collectively “the Company”); (ii) any Company volunteers; and (iii) Andrew Lynch.

For paid Clients, review of the Code of Ethics (COE) and Terms of Use (TOU) below constitute the Coaching Agreement and is effective for participation in self-guided elements of The Program and in Virtual 1:1 interaction. Review by all Clients is required and assumed prior to the first session.

A link to the COE and TOU is accessible via a link on the TtM Scheduler page of the TtM website, which is used to schedule 1:1 (one on one) Coaching or consultation as well as in the website footer which includes the TtM Privacy Policy. Whenever possible, this link will also be included in any materials related to The Program or promotional materials for TtM.



Life Coach Coaching Ethics and Standards (COE)

As a Professional Life Coaching provider, offering services consistent with qualifications in Cognitive Behavioral Coaching, Happiness, and other Coaching Focus Areas, Thrive the Matrix (TtM) commits to upholding Life Coaching industry standards for ethics, including those outlined below. Further, our Code of Ethics seeks to exceed industry standards to ensure Client confidence and service excellence guided by our relentless focus on confidentiality, coaching free from conflicts of interest, and the dignity and respect with which everyone should be treated, no exceptions.

Thrive the Matrix (TtM) LLC, d/b/a Thrive the Matrix Life Coaching, d/b/a TtM has updated our **Code of Ethics (COE)** and **Terms of Use (TOU)** to include the scope of Life Coaching and associated services, disclaimers, certifications / qualifications, age limitations for Clients and the responsibility and participation of parents, caregivers, and agency providers for any Coaching of those under the age of eighteen, as well as financial agreements, and expectations for both the Life Coach and Client. This agreement also includes the Thrive the Matrix (TtM) termination policy and terms and conditions for the Thrive the Matrix Member loyalty program, also referred to as "TMM."

All materials, including videos, audio, worksheets, and homework assignments may be referred to "The Program" throughout this document and any conditions or limitations apply to paid Clients and non-Client users (i.e., website visitors, social media users / viewers across all affected platforms) who review materials included in The Program or in promotional content.

- This agreement clearly communicates to Client and non-Clients the differences between Life Coaching and therapy, or any service provided by a licensed clinician:
 - **Life Coaches are not Clinicians**, including Psychologists, Psychiatrists, or Therapists and are not trained to diagnose or treat any form of mental illness.
 - **Life Coaching tactics and methods may be informed by concepts including Cognitive Behavioral Therapy (CBT)**. In this case, the Life Coach is employing CBT *techniques* to drive meaningful change, a positive mindset, and to help TtM Clients meet their goals. While Life Coaching services include practical advice informed by therapeutic concepts, they do not constitute 'therapy' and will never be used to diagnose or treat any

- condition or diagnose any persons (names or unnamed) the Client may mention when participating in The Program or in engaging with TtM content on its website or social media accounts.
- Clients and non-Clients are restricted and discouraged from including 'real-Life' persons or scenarios in any comments posted in response to Thrive the Matrix content on the official website (www.thrivethematrix.com) and social media platforms used as part of The Program or promotional materials, including guided, topic focused, or promotional videos hosted on YouTube***
- Likewise, TtM will always refrain from mentioning any specific scenarios or naming specific persons in any content, including materials supporting The Program and any Promotional Materials.
- Any scenarios and unnamed persons are anecdotal only and included to support concepts, resources, and tools offered in support of Clients or non-Client viewers or engagers on the TtM website or other platforms and will never claim to represent or diagnose any 'real-Life' persons or scenarios.
- Any scenarios included in Thrive the Matrix worksheets, also referred to here, the TtM website, or social media platforms as "THRIVERcises" are not related to any specific 'real-Life' scenarios and any named persons are fictitious. Any association with 'real-Life' scenarios or persons are purely coincidental.
- TtM will always ensure Qualifications are clear and honest, including career experience, expertise, training, and certifications.
- The Thrive the Matrix website (thrivethematrix.com) includes a banner linked to a video that summarizes the role of the Life Coach and Thrive the Matrix (TtM) certifications / qualifications.
- Whenever possible, content related to The Program or promotional materials for Thrive the Matrix (TtM) will include a link (i.e., via the website banner as mentioned above) or otherwise state certifications / qualifications earned that qualify TtM to offer Life Coaching services.
- TtM employs its official website to list any credentials earned, including associated certification badges, certificates, and the issuing institution**** and related accreditation details.
- The issuing institution names below is not affiliated with Thrive the Matrix, The Program, or any TtM Promotional Materials and included for the purposes of providing credentials and qualifications only.
- Conflicts of Interest: As a Professional Life Coaching service, Thrive the Matrix Life Coaching commits to being self-aware of personal biases and/or conflicts of interest, including disclosing any such conflict and terminating the Coaching relationship should these biases or conflicts make us unable to provide appropriate services.



- Thrive the Matrix (TtM) will refrain from Coaching Clients under the age of eighteen without written consent of a parent, guardian or agency acting on behalf of Clients under 18 years or age.
- Any Coaching Programs offered to those under the age of eighteen will be virtually based with caregiver supervision and participation encouraged, not required Any Coaching Programs requiring in person 1:1 session will require the presence of a Parent(s), Legal Guidance, Custodian, or Agency responsible for the care of the Client.
- Thrive the Matrix Life Coaching d/b/a Thrive the Matrix d/b/a/ TtM will also:
 - Uphold and respect an equitable Coach/Client relationship, regardless of compensation. All TtM Clients can expect the same level of service, regardless of Interaction type, although abbreviated sessions (i.e., 30 min. vs. 60 min. Thrive & Save Sessions) may require an adjustment to the structure and content on the Interaction to ensure this.
 - Refrain from making any specific claims of results or implications of outcomes that you cannot demonstrate or guarantee, although TtM may include stated objectives in any element of The Program. These objectives do not represent a guarantee of results. Rather, they represent the reasonable outcomes possible given proper review and application of the content.
 - Make all efforts to ensure content adheres to a quality standard that makes accomplishment of stated objectives possible for Client and non-Clients engaging with The Program on the TtM website or other platforms.
 - Prioritize Confidentiality and refrain from sharing of any information provided by Clients in any Interactions in any capacity both verbally and in any written form, including in The Program, Promotional Materials, or to any third-party Client or Non-Client.*****
 - Treat all Clients and potential Clients of all backgrounds, including race, ethnicity, religion, nation of origin, gender, sexuality, or any other characteristic, with positive regard.
 - Anyone who engages with TtM, The Program, or other materials including Promotional will ALWAYS be treated with Dignity and Respect.
 - Maintain, store, and dispose of any records, whether through electronic communications, in printed form or electronic files, created as part of Client participation in TtM Coaching that protects confidentiality, privacy and security and complies with any applicable agreements and laws.
 - Obtain written permission from any Client before using their names in testimonials or references.

- Report to authorities any reports or Clients who disclose an intent to harm themselves or others. As a mandated reporter, and with the well-being of Clients our ONLY focus, TtM will inform all Clients of this responsibility before initiating services.

- **Request a refund at contact@thrivethematrix.com** and let us know you'd like a refund on or before the seventh day 11:59pm EST. You will no longer have access to any course materials if you request a refund.
- We will NOT provide refunds for any request that comes more than 7 days following the date of purchase. After day seven, all payments are non-refundable, and you are responsible for full payment of the fees for the Program regardless of whether you complete the Program.
- **Refunds – Virtual One on One Sessions & Interactions:** Thrive the Matrix offers a FREE Meet the Matrix consultation session that can be scheduled on The Company website for all first time Clients. Otherwise, all virtual session options are priced based on frequency and duration and are scheduled individually. In these cases, a refund will be issued.
- **Intellectual Property Rights:** All original TtM content including audio / video recordings for The Program or Promotional Purposes, THRIVERcise worksheets, etc. are the intellectual property of Thrive the Matrix (TtM) Life Coaching and should not be transmitted, altered, or duplicated.
- **Use of Free Content – The Program:** TtM may make programs and/or THRIVERcises free for download on the TtM website or other platforms for a limited time.
