



HAIR & MAKEUP CONTRACT

BOOKINGS

All bookings & details will be arranged with and confirmed by FUSE MGT. Your appointment date and service will be secured when the signed contract and non-refundable deposit of services is received.

TRAVEL FEE.

Travel

fee is applied to clients needing service at hotels and casinos that have paid parking and are farther than 25 mile radius of FUSE MGT. Any parking, valet or toll fees must be paid by the client, if applicable. After that we charge \$1/mile/artist.

PAYMENTS

Payments can be made by cash, credit/debit card, or cash apps. A \$60 **non-refundable deposit** of services is due at time of booking. This secures your date, the time to allow for makeup services for your group. The final balance of services is due before your services. There are no exceptions, and the payments must be received before leaving the makeup area. Please advise your party of this policy.

DELAYS

Please be prepared to start when we arrive. All ladies receiving makeup should have a clean face, clean & dry hair, and be ready to start. This is very important so we can stay on schedule, and we can finish applications in the allotted time. This includes full name and all services needed.

SOCIAL MEDIA & WEBSITE

Photos taken at the trial or your professional photos may be used as examples of our work for future clients to view. Your photographer will receive proper credit for their work. You agree FUSE MGT using these photos, as well as give consent to using your professional photos on our website/portfolio/social media.

If you or a member of your party photographs any members of FUSE MGT, agents or equipment on social media, he/she must tag "@FUSEMGT". You can either link to the Company's Facebook/Instagram page or type in the website address: www.FUSEMGT.com.

LIABILITY

All makeup and hair products and brushes are kept sanitary. All products are sanitized between every client as well. Any skin condition should be reported prior to the application.

DELAYS

A late fee of \$25.00 will be charged for every 15 minutes of delay when you are late for the scheduled time, or if scheduled services exceeds allotted time because of client delays.



Contract will state the times late fees will begin and the amount charged and will be initiated and approved by the client.

TRIAL MAKEUP (BRIDAL AND RED CARPET EVENTS)

A trial makeup (consultation) is available for services that do not include one. This is a separate fee and is due when trial service is rendered. If you are more than 15 minutes late for your appointment, it may be canceled and a late fee of \$25 will be applied to the final bill. Please call at least 3 days in advance to reschedule a trial makeup.

EARLY MORNING START TIME.

Client understands and agrees that any services provided by Company that begin before 8:00am EST will be charged \$50.00

PARKING FEES

Where parking, valet or toll fees may be incurred; the amount will be included with the final bill and due for payment on the day of event.

CANCELLATION

The Artist reserves the right to terminate this contract immediately for any breach of terms, and the contract will become void and all monies given are non-refundable. This booking arrangement cannot be changed after the Artist/s arrives for the appointment. the Artist cancels this agreement for a reason other than breach at any time or is unable to perform the Services for any reason and is unable to find a replacement Artist, the deposit paid will be fully refunded within two weeks.

All deposits paid by the client will be refunded if the contract is canceled within 3 days of contract signing. After the 3 day grace period, should a client cancel the booked event or any service on a contract, the deposit will not be refunded or transferred.

If it is a last minute booking, there will be no refunds whatsoever.

30-Day Cancellation Policy: If you desire to cancel all services 30 or more days prior to your appointment/event, your outstanding balance will be excused, with the exception of the non-refundable retainer fee. Canceling within the 30-day notice will result in any outstanding balance being due immediately. Rescheduling of Services: If you desire to reschedule all services 14 or more days prior to your appointment/event, you shall provide notice to us as soon as possible. If you desire to reschedule all services less than 14 days prior to your appointment/event, the rescheduling will be considered a cancellation, and any outstanding balance will be due immediately.

LIMITATION ON LIABILITY.

The Client shall not hold the Artist or her employees liable and agree to indemnify FUSE MGT for any harm, claim, loss, costs, damage, injury or product reaction to any person or property arising, either directly or indirectly, from the Artist's performance, or any other reason whatsoever.



All brushes, tools and makeup products are kept sanitary and are sanitized between makeup applications.

Any skin condition or allergies should be reported by the Client to the Artist prior to application and, if need be, a patch test of makeup may be performed on the skin to test for a reaction. Client(s) agree to release the Artist from liability for any skin complications due to allergic reactions. If Client(s) have serious skin/health conditions, the Artist will have to discontinue the service(s) due to hygiene complications.

COVID-19 CONTRACT.

Sanitation: We reserve the right to refuse services if unsanitary conditions exist, and/or symptoms of contagious infections/illnesses are present. We will arrive with all tools and products clean and sanitized.

Timing: We will provide a timeline for our services and will add an additional 10 minutes in between each client for proper sanitation and clean-up. Ok

Product Control: In order to ensure proper sanitation is being practiced, we will ONLY use our own products and tools with the exception of lipstick and lip gloss. Cosmetic tools will not be used on multiple clients without proper sanitation after each use.

Our team is happy to proceed with service as planned in the event there is not an executive order in place.

Please note *Some stylists may not be 100% comfortable working during this time due to personal health issues or an ailment of loved ones. An advantage we have during this time is having a team of artists & the capacity to defer to an additional artist if your original stylist is not available.M

FORCE MAJURE CAUSED RESCHEDULE (COVID)

In the event that your appointment/event must be rescheduled due to a force majeure event, all monies paid will be transferred to the new rescheduled date (if we are available on the new date). If we are not available on the new date, any outstanding balance (with the exception of the non-refundable retainer fee) will be waived. Each appointment vent will be addressed based on details at hand. For example: If venues are closed we are happy to follow protocol.



I have read, understand, and agree to the contract terms for my makeup services with FUSE MGT.. The above sections are agreements between the makeup artist , hair stylist, and the client. They are also used to serve as a guide for expectations and full disclosure. I understand that a \$60 non-refundable deposit of my services & signed contract are due at time of booking. The final balance of services is due time of service.
