Community First Choice Revisions

Starting in July 2025. CFC is a part of Colorado's Medicaid program, Health First Colorado. The program will allow eligible Medicaid members to receive home and community-based attendant services **WITHOUT THE NEED FOR A WAIVER**. Provides home and community-based services to eligible members.

- **Promoting self-direction:** Members can choose how they receive services, including whether to self-direct their care or use an agency.
- **Increasing independence:** Members can receive care in their own homes.
- **Simplifying access:** Members can receive services without a waiver.

Some of the services that CFC provides include personal care services, household chores, paramedical services, and protective supervision.
