- 3. All Security/ Maintenance personnel shall be trained on the usage of fire equipment provided.
- 4. Fire Drills shall be conducted once in every 3 months.
- As per report of MSB Inspection committee; the NOC Committee has scrutinized the Inspection Committee Report along with Proposals and recommended for issuance of No Objection Certificate for
