The Board's main responsibility is to enforce Association rules with two goals in mind: keeping property values up and conflicts down.

Below is a quick overview of each role:

- President Leads Board meetings, carries out contracts and documents on behalf of the Association, and ensures all duties are fulfilled in the community's best interest.
- Vice President Steps in when the President is unavailable and fulfills those responsibilities as needed.
- Secretary Maintains meeting minutes, election documents, homeowner rosters, and HOA records (via Dropbox).
- Treasurer Oversees all financial records, billing, invoices, and works closely with the bookkeeper to keep HOA finances on track.

Committees & Members at Large:

- Deeds & Documents Reviews property improvement requests and ensures compliance with CCRs; handles deed restriction concerns.
- o Grounds Oversees landscaping, common areas, irrigation, fountains, streetlamps, signage, and holiday decorations.
- Communications Keeps residents informed and engaged through announcements, events, and social media while fostering community spirit.
- Member at Large Participates in all Board meetings, serves on committees, supports community relations, and prepares for future leadership roles.

We've got exciting work ahead in 2026 - from more speed humps to unifying CCRs, enhancing safety with additional patrols or Flock cameras. These projects require thoughtful discussion and, most importantly, community input. Whether by serving on the Board, joining a committee, or simply attending meetings, your participation matters!
