

ROCKY POINT FIRE/EMS BOARD

All Board members, fire chief, and 8 guests attended the July meeting. After opening matters, the Board unanimously approved the minutes of the previous meeting as well as the treasurer’s report.

For the Board, Bruce announced there would be a Board training session in Chiloquin, there are plans to develop a lawn mower storage area at the back of the bandstand, and Diann is checking into Home Depot possibly donating a shed kit.

Old Business included an update on the insurance coverage for fire engine repairs and the contract with the Forest Service for reimbursement funds when our equipment is used for fire control. The Forest Service donated tools for our new engine and shared compliments for the volunteers controlling a recent fire. Diann also reported on licensing the new engine and the minor repairs performed.

Under new business, Sandy reported the online auction had passed \$5,000. PP&L will be removing some of the aspen trees on the adjacent lot, because they interfere with the power lines. Greg asked for approval of the retyped Fire Chief job description and asked if he was a liberty to correct spelling and grammar errors. The matter was tabled

until Greg could get some clarification on one of the acronyms.

Bruce opened the floor for public input on criteria to be used in the Fire Chief evaluation. Greg provide a summary of the present contract performance criteria. Diane Grieb voiced support for the job description being grammatically correct. Other criteria suggested were that the fire chief develop an understanding and direct contact with the physical features of the district, streets, defensibility, access, fire safety, and local volunteerism.

Greg inserted information on a letter from the Department of Agriculture asking if Rocky Point wanted fiber optics availability. The Board approved having Greg send a letter supporting the development local service.

Fire Chief report covered ambulance drivers, Medicare reimbursements, donations to the department, website fire information and property owner information form, building designated use, distribution of donations, donated pediatric equipment, and I Pads possibly being available from the State of Oregon. Linda Reed’s heart surgery was successful and she’s being released from the hospital.
