Our February guest speaker, Karen Jewell, from the Adult Literacy Program of the Stockton-San Joaquin



The Stockton-San Joaquin County Public Library system proudly offers its free Adult Literacy Program across all 13 library branches. This program provides one-on-one tutoring for adult English-speaking learners who wish to enhance their reading, writing, and conversational skills, as well as develop basic computer proficiency. The Literacy Department is actively seeking volunteers from the community to serve as tutors. The commitment requires just one hour of tutoring per week at a local library branch, for a minimum of six months. As a learner-centered program, the focus is on the individual needs of each participant, allowing learners to choose the areas they wish to improve upon. We provide all necessary resources, including textbooks, workbooks, and access to online training for our volunteer tutors. Additionally, we cover the cost of background checks for tutors.

This program plays a crucial role in addressing the low literacy rates in San Joaquin County. Raising awareness about this valuable service remains one of the greatest challenges, and we encourage community involvement to help make a meaningful impact. ♦


Emma Berchtold and her grandfather Gary Gorham

BOARD OF RETIREMENT REPORT

There is an old saying that the only constant thing is change! Well, SJCERA is no exception to the rule.

During the first two quarters of the year, SJCERA's portfolio has reached cumulative value of \$4.89 billion as of June 30, 2025. At the September 12th, SJCERA board meeting we learned that

SJCERA now has over \$5 billion dollars in assets under management and that our funded level has reached the 80's percentile.

Staff has been working diligently to bring on a new Pension Administration System to replace our current system, in order to better meet the needs of the organization into the future while maintaining the level of service our membership has grown accustomed to.

The Board has begun the process of reviewing the current asset allocations of our investment portfolio.

Current SJCERA Portfolio Allocations are as follows:

Traditional Growth	38%
Principal Protection	9%
Aggressive Growth	16%
Credit	15%
Core Real Estate	9%
Crisis Risk Offset	13%
Total Portfolio	100%

The goal of the review is to possibly modify the strategic asset allocation targets to reflect the Board's current definitions of acceptable investment risks in relation to potential return on investment. This can be accomplished through adjustment within the established allocations listed above or the addition of new asset allocation categories, all with the intent of having the greatest impact on the long-term performance of the portfolio and to design a portfolio that will continue to perform well in all possible investment performance situations.

These are just a few of the 2025 action plan items set out by our CEO Ms. Renee Ostrander. The action plans

are meant to keep SJCERA on the leading edge of the industry providing quality service to our membership while meeting our professional duties and responsibilities!

In addition, we welcomed two new members of the Board, District 3 Supervisor Sonny Dhaliwal representing the San Joaquin County Board of Supervisors, replacing Supervisor Mario Gardea, and Sergeant Jason Whelen who was elected to represent the safety members replacing former board member Captain Chanda Bassett.

We also have a new administrative secretary, Ms. Toni Christian, who is replacing Ms. Elaina Peterson upon her retirement.

Looking forward to seeing you at the next RPESJC event!

- And much more.



Question: Hi Frank, the new tax bill was passed. Could you touch upon some of the changes that are related to us? Thanks!

Answer: On July 4, the so called “One Big Beautiful Bill” was signed into law. Here’s a look at some of the changes.

- One key feature of the One Big Beautiful Bill Act is the extension and revision of some of the tax laws that were part of the 2017 Tax Cuts and Jobs Act (TCJA). This bill extends the 2017 tax cuts set to expire this year, making some of those rules permanent.^{1 2}
- The bill extends the current tax rates of the 12, 22, 24, 32, 35, and 37 percent brackets, respectively. Had the TCJA expired, the rates would have reverted to 15, 25, 28, 33, 35, and 39.6 percent.^{1 2}
- It also increased the standard deduction to \$15,750 for single filers and \$31,500 for those filing jointly for 2025. Both are slightly rising from the current

rate. The standard deduction will adjust for inflation starting next year.^{1 2}

- Starting in 2025, the bill provides a \$6,000 bonus deduction for filers 65 and up in addition to the standard deduction available to all taxpayers. The deduction begins to phase out for individuals with incomes starting at \$75,000, or joint filers with an income of \$150,000. It phases out completely for individuals earning more than \$175,000 and couples earning \$250,000. This bonus deduction is set to end in 2028.^{1 2}
- The State And Local Tax (SALT) deduction will increase to \$40,000 in 2025 and will increase 1 percent annually until 2030. However, in 2030, it will revert to \$10,000. The SALT has a phase out threshold that begins at \$500,000 for single and married filers.^{1 2}
- Some home improvements (such as windows) and residential energy credits (adding solar) end after December 31, 2025. EV credits for new and used cars end after September 30, 2025.^{1 2} ♦
