She had started her position in San Joaquin county in December, 2021 after a lengthy career with the Voter Registration and Election Office in Sacramento County. Ms. Ditty talked about the redistricting process, and displayed maps that depicted both previous boundaries and the newly drawn supervisorial and congressional districts. The event was attended by 40 people. Sharon McGuire won \$80 playing the marble game, while John Austin won the basket donated by Frank Feng/Tamara Langenfeld with Valley Strong Credit Union.

Jimmy Deed (Central Services), Chris Rose (County Administrator), and Jerry Winters (Employment and Economic Development) were first-time attendees among 30 participants at the May 12th luncheon. BOARD OF RETIREMENT REPORT — By Steve Moore



his year 2022, has been very tumultuous. We are looking at a declining economy. We have lately been concerned with inflation which we haven't had for many years. There have been discussions of a recession, stagflation, higher prices especially for petroleum products, supply chain issues,

and losses in both the equity and fixed income markets. As of this writing, the Dow Jones Industrial Average has lost about 5000 points and the market is continuing to be in a state of flux.

The SJCERA Board is currently engaged with our investment consultant Meketa Investment Group in monitoring the current local and global economic situations with China's lockdowns due to Covid 19 outbreaks, the ongoing war in Ukraine, and the global effects of the sanctions levied on Russia for its invasion of Ukraine.

While all these are important to SJCERA and its investment portfolio, the Board of Trustees has been engaged in another very important process since the first of the year: an Asset Liability Study. An asset liability study assesses the plan's liabilities (what is needed to fund the plan and how that is expected to change over time), determines the Board's risk tolerance, and examines how well different asset allocations address the funding needs within the risk parameters set by the Board.

Beginning in February the SJCERA Board has been engaged in five major presentations: First, February 2022 Review of the 2022 capital market assumption. Second, March 2022 Review of asset liability and actuarial concepts. Third, April 2022 Examination and modeling of the current Strategic Asset Allocation. Fourth, May 2022 Examination of initial model output and beginning process of selecting a new long term policy portfolio. Fifth, June 2022 Evaluating revised model outputs and selection of new target allocations.

The purpose of these presentations has been to review the revised asset liability model output by examining several optimized portfolios-based on feedback from the Board. The Board requested Meketa Identify portfolios that produce a 6.75% to 7% return and move global equity to a 60% maximum of the portfolio. They also asked them to continue to examine potential changes to the strategic allocation policy given the current 7% return expectation.

There are a multitude of factors for the Board to consider. Constructing a portfolio that targets a 7% return target is possible but will require policy changes to the portfolio. Upon review and discussion, the Board will consider Meketa's recommendation to consider a portfolio that targets a roughly 7% return on our investments into the future.

t's hard to believe we are half way through the year. What better time to make sure paperwork is in order and financial documents are squared away?

COMPLETE A POWER OF ATTORNEY FORM

Did you know a power of attorney can be used to grant

certain powers to a trusted friend or relative in the event you are unable or unavailable to act when required? The SJCERA Special Power of Attorney (POA) form is specifically designed for SJCERA members and helps to provide peace of mind should you become unable to act on your own behalf. The person you designate will be able to conduct SJCERA business on your behalf. You choose which duties they will be allowed to perform, such as selecting your health plan, changing the deductions taken from your monthly benefit payment, updating your address or direct deposit information, or designating beneficiaries. No one knows what their future holds, but we all know people who have needed assistance due to an illness, injury or a failing memory. Having a power of attorney in place will ensure your needs can be addressed even if you're not able to do it yourself. We hope you never need it, but just in case, be prepared: Complete the Special Power of Attorney form and send it to SJCERA.

REVIEW SJCERA'S FINANCIAL REPORTS

In August, look for the Popular Annual Financial Report (PAFR) enclosed with your benefit statement, or visit the Financials page at www.sjcera.org to read it now. The PAFR summarizes the Annual Comprehensive Financial Report (ACFR) for the fiscal year ended December 31, 2021. Highlights from the reports include:

- The portfolio gained 13.6 percent net of fees, nearly double the assumed rate of return of 7.0 percent
- The net pension liability decreased to \$1.2 billion, the lowest it's been in a decade
- The funded ratio increased to about 77 percent on a market value of assets basis, the highest it's been since before the great financial crisis.

These results are a credit to the Board of Retirement's investment and actuarial decisions and the additional contributions that three employers are making to help decrease their share of the unfunded liability.

Question: Hi Frank, A lot of people are talking about the earning power of I Bonds. Could you tell us more about it and how to get them? Thanks!

Answer: With inflation hovering near 40-year highs, many investors are looking for alternative ways to weather the storm. A Series I Savings Bond may be just the ticket. An I bond is a kind of savings bond that earns an interest rate by combining a fixed rate and an inflation rate. The fixed rate stays the same for the life of the bond and the inflation rate changes every six months. For bonds issued from May 2022 through October 2022, the combined rate is 9.62%. ¹

I Bonds earn interest for 30 years unless you cash them in. You can do this after a year has passed from the time of purchase, but you'll lose the previous three months of interest. However, there is no penalty if you let them mature for five years or more. The maximum amount you can invest is \$10,000 total per calendar year.

To purchase I bonds, you can go to TreasuryDirect.gov and open a free account to make your purchase there. You will need to have the following information ready when you create your online account at Treasurydirect.gov: your taxpayer identification number, current address, checking or savings account information, and email address.
