# BOARD OF RETIREMENT REPORT — By Steve Moore



JCERA continues to provide optimum retirement benefits to its membership. One very important aspect of a retiree's benefits is SICERA Survivor Benefits.

At retirement we each elected one of several options available, to receive our retirement benefit amount. Tied to each option was

a specific survivor benefit to be paid upon the members passing. The survivor benefit options ranged from 100%, 60%, 50%, or a customized percentage as a lifetime monthly benefit paid to your designated beneficiary. Additionally, your beneficiary may receive a \$5,000 one-time benefit (reciprocity can impact this benefit) to help with burial expenses.

Further, the member's current COLA bank balance carries over to the survivor continuance benefit and they will continue to receive the Board of Retirement approved, annual COLA increases for the lifetime monthly benefit paid to your designated beneficiary.

If the member passes while covered by a San Joaquin County health plan or other eligible district health plan and an option with an ongoing benefit was selected, their eligible spouse and any minor children may continue health and dental insurance coverage.

Upon the death of the member, notification to SJCERA should be made as soon as possible in order to ensure the monthly payments continue with minimal delays.

There are two very important publications with more information. Visit www.SJCERA.org to find the "Retirement Benefit Options" and "Survivorship Booklet". Download and read them both!

If you do not recall which selection you made for survivor benefits when you retired or can't find your original retirement documents, you should contact SJCERA to obtain more information and answer any other questions you may have. If you have or are looking into establishing an estate plan, you may wish to request a current actuarial review of your survivor continuance benefit.

#### MEDICARE PART B REIMBURSMENTS

If you're part of the Medicare Part B Reimbursement Program, documents are due January 2nd to receive a full Medicare Part B premium reimbursement, up to the amount remaining in your sick leave bank. Just as a reminder, you must enroll every year moving forward to receive your reimbursement, even if you have enrolled in previous years.

Not part of the Medicare Part B Reimbursement Program? You may be eligible if you meet all the following eligibility criteria:

- I am a retired County Employee or eligible beneficiary.
- I was hired before August 2001.
- I have a Sick Leave Bank Balance (see your SJCERA monthly earnings statement).
- · I am enrolled in Medicare Part B.

If you wish to join the Reimbursement Program, you must submit a completed Medicare Part B Reimbursement form and proof-of-premium documentation (issued by Social Security or Medicare) by January 2nd.

SJCERA will mail forms and instructions to eligible retirees by early December. As it's a busy time of year with the holidays rolling around, please keep an eye on your mailbox so you do not miss the deadline. Visit the Retired Members Forms and Publications page on www.sjcera.org for more information on the form, and Medicare Part B Reimbursement fact sheet.

## **MEMBERS FINANCIAL SERVICES** — By Frank Feng

Question: Hi Frank, as much as I rely on social security, I really don't know too much about it. I am only familiar with the basics. Could you share some "fun facts" about it? Thanks!

Answer: Here are a few critical birthdays and "half-birthdays" that you want to understand because they have importance regarding your retirement income.

Social Security has been a fact of retirement life ever since it was established in 1935. We all know the basics, but here are some things that might surprise you.

- 1. The Social Security trust fund is huge. It was \$2.8 trillion at the end of 2022.1
- Most workers are eligible for Social Security benefits, but not all. For example, until 1984, federal government employees were part of the Civil Service Retirement System and were not covered by Social Security.<sup>2</sup>
- 3. You don't have to work long to be eligible. If you were

- born in 1929 or later, you need to work for 10 or more years to be eligible for benefits.<sup>1</sup>
- 4. Benefits are based on an individual's average earnings during a lifetime of work under the Social Security system. The calculation is based on the 35 highest years of earnings. If an individual has years of low or no earnings, Social Security may count those years to bring the total years to 35.1
- 5. There haven't always been cost-of-living adjustments (COLA) in Social Security benefits. Before 1975, increasing benefits required an act of Congress; now, increases happen automatically, based on the Consumer Price Index. There was a COLA increase of 3.2% for 2024, but there was an increase of 8.7% in 2023.<sup>1</sup>
- 6. Social Security is a major source of retirement income for 67% of current retirees.<sup>3</sup>
- Social Security benefits are subject to federal income taxes but it wasn't always that way. In 1983, Amendments to the Social Security Act made benefits taxable, starting with the 1984 tax year.¹
