PRESIDENT'S MESSAGE – by Bill Mitchell



In October, I along with your delegate, Pat Lynch and alternate delegate, Jerry Herrmann had an opportunity to attend the fall conference of the California Retired County Employees Association (CRCEA), which is our statewide organization. (Pat will have a report for you in the next newsletter.) In addition to speakers on a variety of interesting topics, perhaps the most useful aspect of this meeting is to learn what our counterparts in the other counties are doing and to share our successes with them. As an example, a number of the local associations have a college scholarship program for children/grandchildren of their members. Currently, the RPESJC Board is considering establishing such a program. It is in the process of gathering, from other CRCEA members and from non-profits in San Joaquin County, information such as qualifications, application forms, scoring criteria, and selection processes. A program may be in place in time for an award cycle in Spring 2019 for graduates attending college next fall.

One aspect of RPESJC that sets us apart from almost all other counties is the number of social events we offer each year. For instance, we schedule about four trips, the annual picnic and holiday luncheon, plus our monthly luncheons. These opportunities for socialization and fun are important to meeting one of our core purposes: to improve the quality of life, general health, and well-being of our members.

Speaking of our monthly luncheons, you are by now well aware that they have been held at the Italian Athletic Club (IAC) since November 2017 when UJ's changed ownership. We had been informed quite some time earlier that a transition would occur. Subsequently, the RPESJC Board explored virtually every restaurant, club, and other

venues for an alternative. The IAC was determined to be the only option that had day and time availability, sufficient space, acceptable acoustics, accessibility, and comparable price. As with any endeavor, we have not been able to please everyone, and additional attempts were made recently to find if there was anywhere that had not already been investigated. Ultimately, the Board decided that we will remain at the IAC. The food is good; it is close to the freeway; the sound system works very well; the price is right; and the company is always enjoyable! The number of attendees has been consistent with our experience at UJ's, usually between 40 to 50 people. So, please join us some time and see old friends, hear interesting speakers, and enjoy some good food.

I hope you had a wonderful summer. It's hard to believe the holidays are upon us already (for me, they start with Halloween candy!). My best wishes to you and your families for this season, and for a happy New Year. ❖

ACTIVITIES REPORT — By Carol Carson




SANTA CRUZ TRIP:

Question: It seems that with the new tax law some of us may be in a lower tax bracket than usual. Is it a good idea to convert some of my IRA and retirement accounts into a Roth IRA? Thanks!

Answer: Some of us may have lower income tax brackets as a result of the 2017 tax reforms. Given the outlook for Social Security and Medicare, it is hard to imagine federal income tax rates will ever be lower than they are right now. Since the 2017 tax reform will sunset at the end of 2025, many have wondered if this is a good time to convert a traditional IRA to a Roth IRA. The following are a few factors you should consider before making a decision.

1. One of the biggest advantages of a Roth is that qualified withdrawals will be income tax free (including earnings). If you plan to leave the money in the account for a long time and are able to invest it properly, your accumulated earnings could be significant. This will lead to significant tax savings in the future.

2. Unlike traditional IRAs, there is no Required Minimum Distribution at age 70 ½ for Roth. In addition, Roth assets can be transferred to your heirs without being taxed.
3. A Roth conversion is a taxable event. The amount you convert to a Roth is taxable as your income for that year. If you convert a large amount, the taxable income linked to the conversion could be sizable, and you could end up in a higher tax bracket in the year the conversion occurs.
4. A Roth IRA conversion need not be “all or nothing.” Some traditional IRA owners elect to convert just part of their traditional IRA to a Roth, or to convert the entire balance over multiple years, so they can better manage the taxable income stemming from the conversions.

While a Roth conversion might be beneficial, the move is not for everyone. For some, the resulting tax hit may outweigh the potential long-run advantages. Study the various financial implications and consult a tax professional before making the move.
