**4. FIRST-AID MEASURES**

**Inhalation**

## **5. FIRE FIGHTING MEASURES.**

### **Suitable Extinguishing Media**

Use appropriate fire extinguisher for surrounding environment.

### **Hazards from Combustion Products.**

Under fire conditions this product may emit toxic and/or irritation fumes, smoke and gases including carbon monoxide, carbon dioxide and oxides of nitrogen.

### **Specific Hazards Arising From The Chemical.**

This product is non combustible. However, following evaporation of aqueous component under fire conditions, the non-aqueous component may decompose and/or burn.

### **Precautions in connection with Fire.**

Fire Fighters should wear self-contained breathing apparatus (SCBA) operated in positive pressure mode and full protective clothing to prevent exposure to vapours or fumes. Water spray may be used to cool down heat-exposed containers. Fight fire from safe location. This product should be prevented from entering drains and watercourses.

## **6. ACCIDENTAL RELEASE MEASURES.**

### **Emergency Procedures**

If possible contain the spill. Place inert absorbent material onto spillage. Collect the material and place into a suitable labelled container. Do not dilute material but contain it. As a water based product, if spilt on electrical equipment the product will cause short-circuits. Dispose of waste according to the applicable local and national regulations. If contamination of sewers or waterways occurs inform the local water and waste management authorities in accordance with local regulations.

## **7. HANDLING AND STORAGE.**

### **Precautions For Safe Handling.**

Avoid inhalation of vapours and mists, and skin or eye contact. Use only in a well ventilated area. Keep containers sealed when not in use. Prevent the build up of mists or vapours in the work environment. Wash hands prior to eating, drinking, smoking or using toilet. Store in a cool, dry, well ventilated area, out of direct sunlight. Do not allow to freeze.

## **8. EXPOSURE CONTROLS/PERSONAL PROTECTION.**

### **Occupational exposure limit values.**

### **Appropriate Engineering Controls.**

This substance is hazardous and should be used with a local exhaust ventilation system, drawing vapours away from workers breathing zone. If the engineering controls are not sufficient to maintain concentrations of vapours/mists below the exposure standards, suitable respiratory protection must be worn.
