- ELIGIBILITY:** Artists must be 16 years of age.
- AWARDS:** \$100 First Place
\$75 Second Place
\$50 Third Place
4 Honorable Mention Ribbons
- GUIDELINES:** Entries may be 2 dimensional and/or 3 dimensional.
Maximum size 36" x 36" or a shape no more than 1,296 square inches.
Wearable accessories are acceptable (Will be displayed on a pedestal).
Work can be marked for sale or not for sale.
All entries must be hand delivered.
- CATEGORIES:** 1. Knitting, crochet, tatting
2. Needlepoint, cross stitch, crewel, hand embroidery
3. Weaving
4. Quilts (See size limitation under guidelines)
5. Machine embroidery
6. Other: Any fiber art not fitting in the above categories may be entered in this category, including but not limited to soft sculpture, lace making, needle felting, wet felting, macramé.
Each category must include a minimum of 12 entries to qualify for awards.
Entries will be combined and/or moved to a more appropriate category as necessary.
- ENTRY FEE:** \$10.00 per entry. No limit on number of entries.
Entry fees (if any) can be paid via cash, check or Card
No items that has placed in a previous LCCA show may be entered.
All hanging artwork must be framed or gallery wrapped. No sawtooth hangers. Hanging artwork must have wire attached to the back to be hung.
If artwork requires a special display, please provide one as LCCA is limited on such items.
Artwork remaining at LCCA after 60 days after a show ends is considered abandoned and will be disposed of as LCCA sees fit.
- SPECIFICATIONS:** Two-dimensional must be ready to hang, framed (with wire), wooden dowels, wooden slats, wire, or fish line are suggested) or otherwise ready for exhibition display. Pedestals are provided for 3-dimensional pieces. LCCA reserves the right to reject artwork not appropriately prepared for hanging or considered in poor taste, poor workmanship, or soiled. The Center for the Arts does not accept responsibility for works damaged due to incorrect or poor framing. Artwork must remain for the duration of the show. All art can be marked for sale or not for sale by the artist. Prices CANNOT be changed. *The Center for the Arts maintains 20% of all sales.*
