# PRIVACY POLICY

### **SCOPE OF PRIVACY POLICY**

This Privacy Policy covers Breeze Global Payments, LLC's treatment of personally identifiable information collected from merchants (hereafter "merchant" or "you") and our affiliate partners (hereafter "affiliate partner") who use the Breeze payment gateway services, as well as consumer information that we acquire in the course of our business. This Policy also covers the treatment of personally identifiable information that Breeze Global Payments, LLC®'s business partners may share with it and this website: <a href="www.BreezeCards.com">www.BreezeCards.com</a>, owned and operated by Breeze Global Payments, LLC®, LLC. This Policy does not apply to the practices of companies that Breeze Global Payments, LLC® does not own or control, or to people that Breeze Global Payments, LLC® does not employ or manage.

### INFORMATION COLLECTION AND USE

Breeze Global Payments, LLC® collects personally identifiable information when you register for Breeze Gateway® account, and when you use certain Breeze Global Payments, LLC or Breeze Gateway products and services. Breeze Global Payments, LLC® may also receive personally identifiable information from its affiliate partners and other business partners. When you register with Breeze Global Payments, LLC®, we ask for your contact information (such as your name, street address, email address and phone number), as well as certain information pertaining to your business, along with billing information such as a bank account and/or credit card number. In the course of processing a payment transaction, we typically receive information related to the transaction from the merchant or a financial institution. This normally includes information about the payment that a consumer has furnished to the merchant or financial institution in the course of placing the order. We do not acquire any information directly from consumers through the <u>www.BreezeCards.com</u> Web site. We do not sell your personally identifiable information to third parties. The personally identifiable information we acquire in processing payment transactions varies according to the nature of the transaction and the way in which merchants or financial institutions are using our payment services. It may include, for example, the amount of the transaction, the consumer's name, credit card number and expiration date or checking account number, billing address, and shipping address and in some cases product information related to an order. Breeze Global Payments, LLC® uses the

information collected to fulfill your requests for products and/or services, to process payment transactions, to facilitate billing, and otherwise deliver the payment gateway services. Personally identifiable consumer information is only used to process payment transactions and is never used for any other purpose.. Breeze Global Payments, LLC® does not request or knowingly collect personally identifiable contact information from anyone under the age of 13 and Breeze Global Payments, LLC® does not offer services or sell products to children

### INFORMATION SHARING AND DISCLOSURE

Protecting personally identifiable information about merchants, affiliate partners and consumers is an important part of our business. We share and disclose such information only as described below. Breeze Global Payments, LLC will only send personally identifiable information about you to other companies or people when: 1) we have your consent to share the information; 2) we need to share your information to provide the product or service you have requested; 3) we need to send the information to companies who work on behalf of Breeze Global Payments, LLC® to provide a product or service to you (unless we tell you differently these companies do not have any right to use the personally identifiable information we provide them beyond what is necessary to assist us). Personally identifiable consumer information is shared with third parties (such as banks and credit card processors) to the extent necessary for Breeze Global Payments, LLC® to deliver payment processing services. We also may release personally identifiable information when we believe release is appropriate to comply with law, such as a subpoena, or similar legal process; enforce or apply our Merchant Agreement and other agreements; or protect the rights, property, or safety of Breeze Global Payments, LLC<sup>®</sup>, our users, or others. This includes exchanging information with other companies and organizations for fraud protection and risk reduction. In certain situations, Breeze Global Payments, LLC® may be required to disclose personal data in response to lawful requests by public authorities, including to meet national security or law enforcement requirements. In the unlikely event that Breeze Global Payments, LLC is acquired, merchant account information may be one of the transferred assets. We will notify our merchants via email and/or via a prominent notice on our Web site of any change in ownership or uses of your personally identifiable information, as well as any choices you may have regarding your personally identifiable information.

#### **PASSIVE COLLECTION**

As is true of most websites, we gather certain information automatically. This information may include Internet protocol (IP) addresses, browser type, Internet service provider (ISP), referring/exit pages, the files viewed on our site (e.g., HTML pages, graphics, etc.), operating system, date/time stamp, and/or clickstream data to analyze trends in the aggregate and administer the site.

#### INFORMATION SECURITY

Information security is critical to our business. We work to protect the security of your information during transmission by using Secure Sockets Layer (SSL) software, which encrypts the information you input. We store information gathered on secure computers located in locked data centers. The number of employees involved in the management of the data center that have physical access to these computers is limited. We use firewalls and other security technology to prevent our computers from being accessed by unauthorized persons. We also require that all personally identifiable consumer information sent to us by you be encrypted using SSL encryption. It is important for you to protect against unauthorized access to your Login ID/password and to your computer. Be sure to sign off when finished using a shared computer and otherwise protect the password used to access Breeze Global Payments, LLC® services. No method of transmission over the Internet, or method of electronic storage, is 100% secure, however. Therefore, we cannot guarantee its absolute security.
