To Form Captain Jimmie Hobaugh No. 407 Lodge of Research and Information

We, the undersigned Master Masons in good standing in Lodges working under the jurisdiction of the Grand Lodge of Michigan, respectfully petition for a Dispensation to form a new Lodge of Research and Information, to be known as:

CAPTAIN JIMMIE HOBAUGH NO. 407 LODGE OF RESEARCH AND INFORMATION

This petition is submitted in accordance with Section 4.17 of the Blue Book of the Grand Lodge of Michigan.

PURPOSE AND MISSION

The exclusive purpose of Captain Jimmie Hobaugh No. 407 Lodge of Research and Information shall be researching and publishing Masonic information and educational material, with particular focus on:

- 1. **Preserving Veteran Mason Histories**: Collecting, documenting, and archiving oral histories of Michigan Masons who have served in the Armed Forces, capturing their unique perspectives on how military service has influenced their Masonic journey.
- 2. **Developing Leadership Education**: Creating practical leadership development resources based on proven military organizational principles, adapted for use by Michigan lodges to strengthen officer training and lodge governance.
- 3. **Publishing Research**: Producing quarterly bulletins and annual transactions documenting the contributions of veteran Masons to Michigan Freemasonry and providing educational materials for the Craft.
- 4. **Fostering Veteran Support**: Researching and developing best practices for lodges to better support veteran members and their families, including connections to appropriate services and benefits.

PROPOSED NAME AND NUMBER

Name: Captain Jimmie Hobaugh No. 407 Lodge of Research and Information

Justification: Captain Jimmie Harris Hobaugh (1936-2014) exemplified the highest ideals of both military service and Freemasonry. During his 37-year Coast Guard career, he commanded USCGC

Woodrush (WLB-407) during the Edmund Fitzgerald search and rescue operations. As a 33° Scottish Rite Mason, Past Potentate of Ahmed Temple, and longtime Treasurer of Bethel Lodge #358, he embodied the values of service, leadership, and brotherhood this research lodge seeks to preserve and promote. The number 407, currently available on the Michigan lodge roster, honors his vessel's hull number.
