The motion of **Mr. Templet**, seconded by **Ms. Lee-Sheng**, the following resolution was offered:

**RESOLUTION NO. 133779**

A resolution providing for canvassing the returns and declaring the result of the special election held in the Timberlane Neighborhood Improvement and Beautification District of the Parish of Jefferson, State of Louisiana (the "District") on Saturday, May 4, 2019 for authority to levy and collect an ad valorem tax in the District; and other matters in connection therewith.

**WHEREAS**, the Board of Commissioners of the Timberlane Neighborhood Improvement and Beautification District of the Parish of Jefferson, State of Louisiana, requested that this Parish Council, acting as the governing authority of the Parish of Jefferson, State of Louisiana, authorize the Timberlane Neighborhood Improvement and Beautification District to hold an election and to levy and collect the special tax provided for therein, all in accordance with the terms of Resolution No. 132966 adopted on January 16, 2019.

**BE IT RESOLVED** by the Jefferson Parish Council, acting as the governing authority of the Timberlane Neighborhood Improvement and Beautification District of the Parish of Jefferson, State of Louisiana:

**SECTION 1.** That this Council does now proceed in open and public session to examine the official certified tabulations of votes cast at the special election held in the Timberlane Neighborhood Improvement and Beautification District of the Parish of Jefferson, State of Louisiana (the "District"), on Saturday, May 4, 2019, to authorize the levy and collection of an ad valorem tax in the District, said tabulations having been prepared and certified by the election officials serving at the designated polling places, and this Council does now further proceed to examine and canvass the returns and declare the result of the special election.

**SECTION 2.** That a proces verbal of the canvass of the returns of said special election be made and that a certified copy thereof shall be forwarded to the Secretary of State, Baton Rouge, Louisiana, who shall record the same in his office; that another certified copy thereof shall be forwarded to the Clerk of Court and Ex-Officio Recorder of Mortgages in and for the Parish of Jefferson, State of Louisiana, who shall record the same in the Mortgage Records of said Parish; and that another copy thereof shall be retained in the archives of this Council.


**SECTION 3.** That the result of the said special election shall be promulgated by publication in the manner provided by La. R.S. 18:1292.

did in public session, examine and canvass the returns of the election, there having been submitted at said election the following proposition, to-wit:

**PROPOSITION  
TIMBERLANE NEIGHBORHOOD IMPROVEMENT  
AND BEAUTIFICATION DISTRICT  
PARISH OF JEFFERSON, STATE OF LOUISIANA  
(SPECIAL ASSESSMENT)**

Shall the Timberlane Neighborhood Improvement and Beautification District, Parish of Jefferson, State of Louisiana (the "District"), be authorized to levy and collect a special assessment in an amount not to exceed One Thousand Nine Hundred Fifty Dollars (\$1,950) on all property subject to taxation within the District, with an estimated \$1,012,050 Dollars reasonably expected to be collected from the levy of the assessment for one year, for a period of 10 years, beginning with the year 2019 and ending in and including 2028, for the purpose of promoting and encouraging the improvement, beautification, and overall betterment of the District, including, but not limited to, the acquisition, construction, improvement, operation and/or maintenance of recreational and other facilities in furtherance of the authorized purposes of the District?

There was found by said examination that, according to the tabulations prepared and certified by the Clerk of Court for the Parish of Jefferson, a copy of which is attached as Exhibit A, the following votes had been cast in the District at the election FOR and AGAINST, respectively, the above Proposition, to-wit:




The polling places above specified being the only polling places designated at which to hold the said special election, it was therefore shown that there was a majority of 17 votes cast FOR the Proposition.
