- President's Report
 - > 2024-25 Review
 - Board met 7 regular meetings, 1 special meeting this year and annual meeting
 - Thank Board great efforts to assist—watering new landscaping
 - Thank Dr. and Mrs. Peralta and Scott Ray who are not seeking reimbursement
 - Fee Increase--\$5 a quarter mainly inflation and lack of competition, details in letter
 - Attempts to seek bids—for repairs and replacements been better
 - No competition for pool bids
 - Two bids for landscaping, not a big difference, competitive
 - Use of credit line for major replacements not in reserve budget
 - Got a free recycling bin from Waste Co and promotional discount for Boxwood
 - Got AEP to fix street lights burnt out (thanks Kevin)
 - Delt with neighbor complaints against other neighbors
 - Things we did not do—pay legal fees to pursue amending docs after reviewing survey results with no concept getting 75% favorable response
 - Chickens (32%) , short-term rentals (50.5%), flagpoles (71.4%)--\$750 \$2,000 saved
 - Petition city for golf cart street designation
 - Leadership transition (Cheryl Morris, Andrea Singy, Avi Trill, me)
 - 8 years on board, 6 leading, Christmas lights
 - Invitation to step up
- Committee Reports Year in Review
 - Pool Committee—Hannah Bilodeau
 - Need new Pool Committee Chair
 - Last year successful season despite issues with security access system
 - Issued credentials until system broke toward the end of the season
 - New Salt Cells purchased keep saltwater system working (\$3,527.55)
 - Volunteers hang shade sails and set up furniture
 - Pool opens Saturday May 10, close 2 weeks earlier after Labor Day
 - New rule no more than e parties per day, first come, first reserved
 - Started emailing about parties instead of just using Facebook neighbors group post

- Will need pool attendants \$5 night/M & W custodians \$10
- Pitch for volunteers to help with attendants, party reservations, etc.

 - Committee took over pool security and access from pool committee
 - Pool access solutions and options
 - Pricing internet with Glow Fiber in case needed
 - Directory updated and sent out (thanks Suzanne)
 - Fall and Spring Newsletters went out

 - Photo contest to update website—April 15 deadline
 - Pitch for volunteers for directory updates, newsletter and pool access
