- Net Mounting: Has been lowered.
- Grouting Repairs: Will have this repaired at the end of the season
- Chair Repair / Replacement Cycle: This is ready to go need an \$1800 deposit from Jennipher Lucado to get started
- Cleaning Mold Build-up on Table Tops / Chairs: Will need to talk to Janeen to have these cleaned prior to placing items in storage for the winter. If they can't be cleaned, it may be time to replace the table tops.
