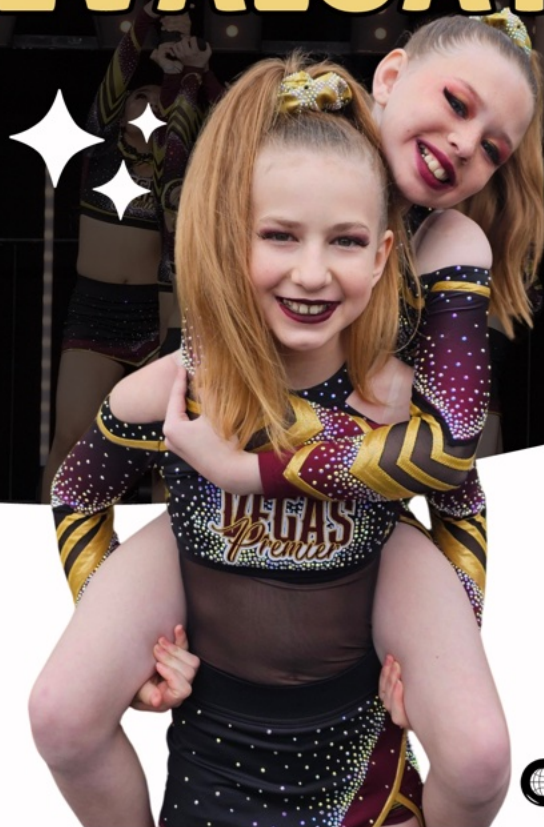

TUITION PAYMENTS	<p>Tuition payments are due prior to each month. For example, July tuition is collected in June payments. Depending on the payment option selected tuition will be paid by the scheduled due date. An active card must be stored on file on the account at all times. NO EXCEPTIONS. If a payment is declined, an email notification is sent and late fees can occur if not handled immediately. Please refer to "Payment Late Fees" section.</p>
PAYMENT LATE FEES	<ul style="list-style-type: none">• 1 day late \$5• 2 days late \$10• 3 days late \$15• 4 days late \$20• 5 days late \$25 (each additional day thereafter increasing by \$5)• If more than 5 days late, the athlete will not be allowed to participate in any practice, class, camp or competition. If a competition or event is missed due to late tuition payments there will be a \$250 charge assessed in addition to late fees.
DISCOUNTS	<ul style="list-style-type: none">• Sibling discount \$25/month off tuition on any additional active sibling. If sibling withdraws from the program for any reason the discount will automatically be void.• If one child is enrolled in cheer and the other is in a class, the discount of 25% will be applied to the child in the class.• Military discount of \$15/month off tuition, must show proof to qualify.• First responder discount of \$15/month off tuition, must show proof to qualify.
EARLY WITHDRAWAL/ TERMINATION FEE	<p>If an athlete is removed from their competitive team for any reason an immediate \$750 fee (per athlete) will be assessed. If payment is not made immediately, VPA reserves the right to submit the account to collections. No refunds on any fees including but not limited to: ProShop purchases, uniform, shoes and competition fees previously collected. No exceptions.</p>
PROGRAM PRIORITY	<p>VPA allows any competitive athletes to participate in other school or competitive programs but it is in agreement that any scheduled VPA practices and events (including competitions) will be the priority. Any additional activity schedules must be submitted for approval ASAP and will be reviewed by VPA staff for approval.</p>
CROSSOVER	<p>Crossover athletes are those who have been selected to compete on more than 1 competitive team at VPA. There is an additional \$75/month tuition charge to cover crossover competition fees throughout the entire season. If at any point VPA coaches believe that crossing to multiple teams is becoming too much for the athlete to handle, or the athlete isn't giving the same commitment to each team, they will be removed from the additional teams and will only compete on their home team. NO refunds on fees collected. If an athlete is asked to cross mid season, there will be a back payment due for crossover fees previously collected to cover upcoming competitions.</p>

CHOREOGRAPHY CAMP	<p>Attendance at camp is mandatory for all athletes. Choreography can begin as early as July 2025 and our target is to be finished by August 2025 to ensure we are prepared for upcoming competitions. You will receive the choreography dates ASAP. As choreography camp is mandatory, if there is an unexpected reason that any athlete is unable to attend, a stand-in for that athlete will be scheduled and a fee of \$125/day will be assessed to the missing athlete's account. No exceptions. Videos of the choreography missed will be provided but it is the sole responsibility of that athlete to learn what was missed in a timely manner according to their coach.</p>
SPORTSMANSHIP	<p>We take pride in the cheer community we have been building. VPA holds all staff, athletes, and families accountable when it comes to good sportsmanship. Any inappropriate behavior from athletes and families including but not limited to, gossiping, yelling negatively, treating other athletes or another gym's athletes/families/staff with disrespect in person or on social media will be addressed immediately as VPA deems appropriate. VPA reserves the right to remove the athlete from our program at any time and assess the termination fee. NO refunds will be given. Please see "Demerit System" for more information.</p>
ATTENDANCE POLICY	<p>Attendance is crucial to the team's success. VPA staff must be notified privately via band of an absence prior to 4 hours before a scheduled practice to allow coaches to make changes as needed. Any absence less than 4 hours will be automatically considered unexcused and will accrue a \$50 fine. Please refer to "Time Commitment", "Pre-Arranged Absences" and "Absences for Sickness/Injuries" for more information. Absences two weeks leading up to a competition/event can affect an athlete's position on the team and a \$60 fine/missed practice and the athlete's position on the team will not be guaranteed and could result in termination. Competitions and special performance events are mandatory for all athletes on teams. Athletes must arrive at event call times in full uniform (makeup, hair and shoes on). NO EXCEPTIONS. Please see "Competition/Special Event Performance Etiquette Fees" section.</p>
PRE-ARRANGED ABSENCES	<p>Parents and athletes must fill out the pre-arranged athlete absence form for any scheduled expected absences throughout the season. This allows us to do our best to avoid scheduling conflicts. This does not guarantee the change of schedule for events or waive any fees associated with the absence. Examples of excused absences are as follows but are not limited to: contagious sickness/injury with a valid doctor's note, death in the immediate family, and approved prearranged vacation time. VPA staff reserve the right to make considerations as to what is deemed excusable throughout the season. Parents need to contact VPA staff for approval with an advanced notice to allow coaches to make updates to their planned practices.</p>
ABSENCES FOR SICKNESS/INJURIES	<p>Must have a valid doctor's note. However, we encourage athletes to still come to practice (wear a mask if necessary) but will sit out and watch the practice to ensure they are aware of any potential changes. Please refer to "Time Commitment" section. VPA reserves the right to accept and potentially waive absence fines within 2 weeks of a competition with a valid doctor's note.</p>
DEMERIT SYSTEM	<p>The VPA Athlete Code of Conduct and expectations will be reviewed and signed at the beginning of the season with all parents and athletes. We will be practicing a program that gives 3 demerit points throughout the entire season. VPA staff will issue demerit points for any behavior deemed inappropriate and the athlete can be subject to removal from the team. No refunds on any collected fees will be given for any removal from the team and the athlete's account will be assessed a termination fee. No exceptions. Please see "Sportsmanship" and "Financial Agreement" sections for more information.</p>

OTHER ACTIVITY CONFLICTS	All star cheerleading requires the time commitment of the athlete and parents/guardians. Members of our program are expected to make VPA events and practices priority over other extra-curricular activities. If the athlete has other events that may conflict, a schedule must be submitted to VPA management ASAP for approval.
PARENT AND ATHLETE COMMUNICATION	We will be using the app "Band" to communicate with all parents and athletes in the cheer program on a regular basis. Families are responsible to keep up with all communications posted. Other options of communication are available via email info@vegaspremierathletics.com or call/text 725-279-8531. All communication with coaches must be done via Band. Any communication needs to remain within business hours/days only, unless there is an emergency. Athletes are welcome to communicate with coaches via band however they are considered minors and need parents/guardians to communicate any potential absences directly to VPA staff via Band.
ATHLETE ATTIRE/DRESS CODE	During team practices, athletes must have their hair neatly pulled up in a high pony tail with their practice bow and wearing the sports bra and shorts assigned by their coaches. Cheer (competition) shoes must be changed into to be worn during practice and competitions only. More detailed information will be sent out when teams are assigned. With safety in mind, no chewing gum or jewelry is allowed in the gym and at competitions. Nails must be kept clean and short with no embellishment that could cause injury is allowed during the season. During competitions/special events nails can only be in neutral or gym colors. During competitions/special events athletes must be in gym colors at all times as they are representing the gym. This includes jackets and sweatpants to keep warm. More details from coaches will be communicated throughout the season.
CLASS/CAMP ETIQUETTE	Athletes will be expected to attend any classes/camps they have enrolled in. If an athlete is to miss a class for any reason, VPA management must be notified prior to the absence to be EXCUSED. This allows us enough time to notify the coaches. Cheer program athletes are required to attend their classes per the "unlimited class" guidelines. If an athlete has more than 2 CONSECUTIVE UNEXCUSED absences, the athlete will be dropped from the class and a fine of \$10 will be assessed to the account. Email communication will be sent to the parent/guardian and the athlete is required to re-enroll for another class per the guideline that works within their family schedule.
COMPETITION/ SPECIAL PERFORMANCE EVENT ETIQUETTE FEES	An approximate range of \$50-\$250 fee (depending on issue) will be assessed to the account for any issues on competition/special performance event days listed but not limited to: <ul style="list-style-type: none">• Arriving late to event call times.• Forgetting, missing uniform items including hair accessories, shoes and makeup.• Removing or losing athlete wristbands/credentials on competition days.• Missing award sessions without coach and owner's prior approval.• Missing mandatory competition events, team scoresheet/video reviews etc.
LATE ENROLLMENTS	Any collected performance fees (uniforms, comp fees, music, choreography etc.) will be calculated and need to be paid prior to starting on the team. VPA management will create a payment agreement that the parent/guardian will be responsible for the remainder of the season. Coaches and owners have the right to hold additional athlete enrollments after choreography has been completed with the exception of alternates. If any uniform/shoe orders are needed the athlete's account will be also be subject to shipping fees paid to the vendor.

END OF SEASON BANQUET/EVENTS	Vegas Premier Athletics and the Vegas Premier Athletics Booster Club will host an end of season banquet celebrating the hard work and achievements of our cheer program from the season. Expected to be May 2026 and the exact date of the event is TDB.
TRADEMARK & LOGO REGULATIONS	The name "Vegas Premier Athletics", team names and the logos are the property of Vegas Premier Athletics, LLC. and are protected under law. Permission is required before anyone may produce or sell any product that uses or displays our name or logo. All sales involving Vegas Premier Athletics merchandise must go through Vegas Premier Athletics, LLC. No one can produce ANYTHING with the words "Vegas Premier Athletics", "VPA" or the logo without written permission. All items produced displaying team names must also be approved. Furthermore, once permission is granted, all final designs must be approved before they can be produced. Any violation of this may result in dismissal/early termination of the athlete from the program. No refunds will be given.
BOOSTER CLUB & FUNDRAISERS	Vegas Premier Athletics Booster Club (VPA Booster Club) is a non-profit parent ran club that helps to fundraise for individual athletes and gym events. Membership fees may apply to participate. Further communication will be distributed by the board members of the VPA Booster Club.
UNIFORM & SHOE SIZING	Prior to finalizing any orders that require specific athlete sizing, parents must sign off on the athlete sizing form in a timely manner. Any incorrect sizing or reorder costs are the responsibility of the parents and will be charged to the athlete account. No refunds or returns as shoes are custom ordered.
TIME COMMITMENT	Teams will practice at a minimum of 1-2 days/week. You can expect extra practices to take place during competition season and for extra work needed at the team coach's discretion. Attendance of every athlete is incredibly important to the entire team's success. Missing practice can affect the athlete's position on their team. Athletes planning on missing any practices are required to notify management ASAP. ALL missed practices within 2 weeks leading up to a competition or performance event will be assessed a \$60/day fine as missing athletes make it difficult for the entire team to be successful since each athlete is important for a completion of the team's routine. Athletes that are injured are required to have a written doctor's note and must attend all practices to stay current on any possible changes. Upon returning from an injury/illness a written doctor's release must be provided stating they are able to participate again. Coaches reserve the right to replace/terminate an athlete who misses practice within two weeks before a competition/event. No exceptions. Alternate rules and fees apply.
UNLIMITED CLASS REGULATION	We will give priority enrollments to our cheer athletes for classes since unlimited classes is a large benefit for our program. We would like to continue to offer this benefit but we need the athlete and parents to commit to taking weekly classes to aid in skill progression throughout the entire season. Each elite athlete will be required to attend 1 tumbling, 1 conditioning and 1 flight school (stunt) class of their choice. Each prep and novice athlete will be required to attend 1 tumbling and 1 conditioning or flight school (stunt) class of their choice. Additional classes are optional but we strongly feel that taking advantage of this benefit will ensure that our athletes and teams are prepared for competition season and are able to learn/maintain skills. VPA staff will do our best to work with parents and their schedules at enrollment to schedule these classes.

TARDY POLICY	Athletes are expected to arrive a few minutes prior to the scheduled practice/class to be ready and in the gym by the start time. Athlete accounts will be charged \$10 after 3 tardies. Coaches will review the VPA athlete code of conduct at the beginning of the season where timeliness and expectations will be discussed further.
TRAVEL COSTS	All travel are the athlete's family/guardian's responsibility. The VPA Booster Club helps to set up room blocks to help raise funds for the season's events, they are a separate entity and have no financial relation to Vegas Premier Athletics gym. It is not mandatory to book in their room block but encouraged as a portion goes back to our athletes.
SMALL GROUPS & SOLOS	There will be a separate information packet/agreement for these athletes. Athletes will be held to the same code of conduct standards as regular season athletes. More information will be released as we get information on competition opportunities for the season. Parents must notify VPA staff of any interest in participation and will be responsible for any fees covering the competition, practice times, travel costs, uniforms, and coaching fees.
ALTERNATE ATHLETE	Alternate athletes fill in when needed during the season and are required to follow the same rules and code of conduct as all regular season athletes. Alternates will be responsible for paying the competition fees, shoes, hair accessories, uniform fees (if no used uniforms available to borrow), and other applicable registration fees such as USASF annual fees. Alternate athletes and families are required to follow all of the program guidelines and code of conduct similar to regular athletes.
PARENT/FAMILY PARTICIPATION	We highly encourage all athletes and their families to participate in all the events throughout the season. Team representatives (parents of athletes) will be selected from each team and will help with communication, team bondings, event planning and coordinate special gifts and treats for the athletes throughout the season. These representatives spend their own time to help make the season special for everyone and will reach out via the team's Band if anything is needed throughout the season.
