

LUX CHRISTI HARVEST FESTIVAL

2025 VENDOR APPLICATION

1. BOOTH DESCRIPTION:

- Vendors' Market spaces are located outdoors at Happy Hens Farm in Ramona. All vendors are responsible
 for providing their awnings, tables & chairs. Your booth must fit within the boundaries of the space you have
 purchased. This includes all containers, garbage receptacles, cooking appliances, etc. If the merchandise
 or equipment extends beyond the booth space, you will be required to purchase two spaces.
- Happy Hens Farm will NOT provide access to power. If electricity is needed, you must bring a generator and fuel.
- Confirmations will be sent to you upon receipt of full payment and pending the approval of your merchandise. Your booth assignment will be given to you upon your arrival at the festival. Booths will be filled on a first-come, first-served basis.

2. BOOTH FEES:

- \$100 tax-deductible donation for a 10' x 10' space (payable in advance), donate a live auction item to our Spring Gala (suggested retail value of \$50+), and receive a shoot-out from the stage throughout the Harvest Festival. Please have the item prepared for auction and delivered to Lux Christi by September 22nd.
- \$150 tax-deductible donation for a 10' x 10' food booth space (payable in advance). FOOD VENDORS MUST OBTAIN A HEALTH PERMIT.
- \$300 tax-deductible donation for a Food Truck (payable in advance). FOOD VENDORS MUST OBTAIN A
 HEALTH PERMIT.
- All vendors must submit a copy of their Certificate of Liability Insurance to cover you for the event. You must name Happy Hens Farm as an additional insured.
- To be accepted as a vendor, complete and mail the Vendor Application form, Certificate of Liability Insurance, and a check made payable to Lux Christi Academy and/or live auction items by September 22, 2025.

3. REFUNDS:

- NO REFUNDS after September 25, 2025.

5. MERCHANDISE:

6. RESTRICTIONS:

- NO animals will be allowed on Happy Hens Farm grounds (including Service Animals).
- Food and/or beverages will be sold only by food vendors. This includes bottled water, snow cones, popcorn, cotton candy, etc. (Exceptions include canned, jarred, or packaged items.)
- This is a Christian, family-oriented event. NO guns, knives, anti-Christian, or pornographic material will be allowed. Violators will be subject to immediate removal without refund. The Lux Christi Festival Committee reserves the right to remove objectionable exhibits.
- Vendors seeking to promote political expression, special interest groups, and religious or social commentary will not be accepted.
- You are responsible for paying all applicable sales taxes on your merchandise.

7. RAIN POLICY: Lux Christi Harvest Festival will continue, rain or shine, with no refund of fees.

8. SET-UP INFORMATION:

- Lux Christi Harvest Festival committee members will greet vendors upon arrival and be available to assist throughout the festival.
- Please be set up by Saturday at 3:00 PM. If you will be delayed, you must notify the Lux Christi Festival committee by calling Tiana Hooker at 619-241-3999. Failure to do so can result in forfeiture of booth fees.
- Vehicles will be permitted in the market area for unloading, but must be removed immediately after unloading and before 3:45 PM. No vehicles will be allowed into the market area during festival hours.
- 9. TEAR-DOWN TIME: Booths must remain set up from 4:00 PM 8:00 PM.
- 10. LIABILITY: The Lux Christi Festival Committee, its officers, agents, employees and other representatives, will not be held liable, and they are hereby released from liability for any damage, loss, harm or injury to the person or property of the exhibitor or any of its representatives resulting from theft, fire, water, weather, accident or any other cause. The exhibitor shall indemnify, defend, and protect the Lux Christi Festival Committee against all claims, demands, suits, liability, damages, loss, costs, attorney's fees and expenses of whatever kind or nature, which might result from any action or failure to act on the part of the exhibitor or any of its officers, agents, employees or other representatives.
