This packet will provide you with the information needed to obtain an Operational Permit to sell 121 \$(5, \$/ & 20021), 5 (: 25.6 within the Middleton Rural Fire District and Star Fire Protection District.

NONAERIAL COMMON FIREWORKS: Any fireworks such as ground spinners, fountains, sparklers, smoke devices or snakes designed to remain on or near the ground and not to travel outside a fifteen-foot (15') diameter circle or emit sparks or other burning material which land outside a twenty-foot (20') diameter circle or above a height of twenty feet (20'). Nonaerial common fireworks shall not include firecrackers, jumping jacks, or similar products.

Additional application and permits are required for stands operating within the city limits of Middleton or Star It shall be the responsibility of the owner/operator to contact the city and complete all requirements prior to the deadlines outline on page 2.

Fee: \$50.00 (\$25.00 Permit Fee & 25.00 Inspection Fee) During our review of the application and email invoice with payment link will be sent.

Inspections: The Fire Code Official will contact each operator via email on June 19, 2024, to schedule inspections for opening day on June 23, 2024. Please note that each city may also require a building official inspection and it shall be the responsibility of the owner/operator to schedule the required inspections.

All Temporary Fireworks Stands are subject to the APPROVAL of the Fire Code Official once they are set up. Stands must meet all the criteria listed on the Inspection Form before a permit will be issued. It shall be the responsibility of the owner/operator to perform a self-inspection prior to the arrival of the Fire Code Official. The Fire Code Official will present the owner/operator with copies of the inspection and permits from the city in which they stand is operating. All permits must be posted conspicuously inside the stand during all hours of operation.

The Fire Code Official or designee has the authority to perform compliance inspection at random times and without notice. Fire Code Official or designee may or may not be in uniform and may or may not be utilizing an official vehicle. Stand found to be not in compliance will have their permit revoked on scene by the inspector. Stands with revoked permits must immediately cease operations and sales. The Fire Code Official or designee may re-issue the permit, at their discretion; after all unsatisfactory items are resolved.

No temporary fireworks stand used during the summer sales period shall be erected before June 15th. The premises on which such fireworks stand is erected shall be cleared of all temporary fireworks stands and debris no later than twelve o'clock (12:00) noon on July 12th. No temporary fireworks stand used during the winter sales period shall be erected before December 15th. The premises on which such temporary fireworks stand is erected shall be cleared of any and all temporary fireworks stands and debris not later than twelve o'clock (12:00) noon on January 8th.

NON-AERIAL COMMON FIREWORKS WINTER SALES - May be sold at retail and used beginning at twelve o'clock (12:00) midnight on December 26th and ending at twelve o'clock (12:00) midnight on January 1st of each year.
