



STAR FIRE PROTECTION DISTRICT ENCOURAGES RESIDENTS TO TAKE PART IN SURVEY

Star, ID, March 13, 2024 – Star Fire Protection District released a community wide survey this week. The survey seeks to gather feedback on public safety services, funding constraints on the District due to legislative changes made in 2020 and the impacts of growth. The survey is available on the District's website, https://midstarfire.org/, or directly at https://bit.ly/starfiredistrictsurvey. The survey takes approximately 5 to 7 minutes to complete.

The survey also serves to educate the community about facilities and District funding realities. The District's population has increased 55% percent since 2018 to approximately 22,000 people and that growth is projected to continue. The number of buildings in the District boundaries has increased by more than 2,501 since 2018 to approximately 7,163 structures. Fire protection and EMS facilities have not increased since 2020 when the community passed a bond measure to refurbish the property West State Street into Station 51, District Headquarters and Apparatus Maintenance Division. Station 51 solved the District's immediate needs at just \$93 per sq/ft. The District's optimal response time for Fire Protection/EMS services is 5 minutes in order to minimize property loss and serious or fatal injury. The District's current response time within the Station 51 and Station 52 service areas is up to 5 minutes. The current response times outside of those service areas can range from 5 to 20 minutes, particularly to the north and northeast of Station 51, where growth is projected to continue, and Highway 16 will be expanded.

Funding the District's increasing service demands has been a challenge. With the passage and impact of HB 389 in 2021, the District's budget can only grow by 3% annually with a maximum of 8% depending on the amount of new construction, creating a funding gap between the amount the District receives in property taxes and the actual cost to provide fire protection and EMS services throughout the District's 55-square mile service area. The District has implemented development impact fees, but those fees can only cover the cost of capital facilities due to growth, not the operational and personnel needs to staff and equip a needed fire station in the northeastern area of the District. On top of this, the costs associated with fire personal protection equipment and general operational expenses have increased from 30-100% due to inflation since 2020.

The District is planning to build a new Station 55 on Floating Feather Road to better serve residents in the northeastern portion of the District. The plan for building and staffing new facility to adequately serve the Station 55 service area can be found on the District's website https://midstarfire.org/. Once complete, Station 55 will reduce response times in that area and reduce service demand on Station 51 and Station 52 that currently cover this area; thus, improving service coverage throughout the entire District. The District is asking for the community's feedback on a potential permanent levy override to cover the increased operational costs unable to be funded by current property taxes. The estimated cost to a homeowner would be approximately \$53, or about \$4.50 per month, per \$100,000 of assessed value (less homeowner's exemption) annually. Based on community feedback, the District Board may

consider placing an override levy ballot measure for the May 22 primary election date. A permanent levy override requires a 66.67% voter approval to pass.

"Many factors contribute to our budgetary challenges to keep our residents safe such as inflation, the cost of personnel safety equipment, growth, and the impacts of legislation enacted in 2021" said Chief Greg Timinsky. "Due to the impacts of the legislative changes, it limits our ability to increase our annual budget by the necessary amounts needed to operate, retain and increase staffing, and to equip the District's facilities. For fire districts, more than 97% of funding for operational costs comes from property taxes. When property tax cuts are put into place it directly affects our operating budgets. Impact fees can be used to cover the cost to build Station 55, but without a permanent levy override, there won't be any firefighters in that station rolling out to help people in need," he added. "We're exploring ways to keep our public safety service levels on pace with growth. The survey will identify community priorities to guide the District's decisions."

"We encourage residents to invest a few minutes to share their feedback," said SFPD Board Chair, Jared Moyle.

About Star Fire Protection District:

Led by Chief Greg Timinsky, the Star Fire Protection District currently serves 22,000 residents from its two stations, Station 51, on State St. in Star and Station 52 on Kingsbury Road. Star Fire Protection District is one of the fastest growing districts in Idaho. The District provides public safety services including fire protection, emergency medical services assistance, public safety education programs, hazardous materials and natural disaster response, building safety inspections, and fire code compliance and plan review. The District is governed by a three-member Board of Commissioners elected by District residents. Current staffing consists of 23 full-time firefighters. The administrative staff is shared with the Middleton Rural Fire District. This shared administration agreement, often referenced as "Mid/Star Fire," saves EACH District an estimated \$430,000 per year in personnel costs.









CROSSTAB DATA: AGE




People aged 18-44 are underrepresented in the survey by 10.0%


Estimated turnout (%), estimated ballots cast by age group





















Once complete, Station 55 will reduce response times in that area and reduce service demand on Station 51 in downtown and Station 52 in the west that currently cover this area, enabling them to be more readily available to meet the public safety needs in those areas.


Impact Fees revenue will be used to pay for the new fire station in 2024. Impact fees may not be used to cover the cost of annual operational expenses (personnel, equipment, etc.). A levy Override is needed to fund the staffing and operations of the new fire station.



The new station will require a minimum of 9 personnel to be properly staffed. The District needs a total of 12 additional personnel District wide to achieve optimal response times from Station 51, Station 52 and the new station service areas. The annual cost of additional staffing and operating expenses would be an estimated \$2.2 million.




Current State Statute limits the ability of Fire Districts to increase their budgets on an annual basis. Staffing and operating the new Station is estimated to increase the District's budget by 45-50%. The districts only source of revenue to cover the increased cost is a permanent levy override that must be approved by 66 2/3rd percent of voters.





Given the information you have, how supportive are you of the District seeking a permanent levy override to fund the operational expenses associated with this new fire station at an election on May 21st?




- Developer fees, not a levy, should cover station development, apparatus purchase, equipping, plus first year of staffing






Where do you live?





How long have you lived in the area?



What is your gender?




