Discussion regarding 2025 Proposed Budget.

Council Member Mikalic explained that the borough is in a deficit. There were bills of more than \$100,000 that were unpaid and with rising costs in the economy. The refuse account is currently delinquent as well. Unfortunately, there is a need to raise taxes. The current rate is .804 mil and the increase will change to 1.608 mil. Solicitor Watt explained the procedural backdrop for this process.
