

**HARVEYS LAKE BOROUGH, LUZERNE COUNTY  
REGULAR COUNCIL MEETING MINUTES**

**April 19, 2022**

**President Hilburt welcomed everyone, called the meeting to order at 6:00 pm, and lead the Pledge of Allegiance He announced that the meeting was being recorded, Mayor Rush was also recording the meeting.**

**Approval of Minutes of Previous Meeting** – A motion to waive the reading and accept the Minutes of the Regular Council Meeting on March 15, 2022 made by Tom Kehler and seconded by Michelle Boice. Motion passed.

**Comments from Residents:** Todd Evans had questions about a notice of violation from BHW to his neighbor. He asked when fines will start being levied and will the wall be removed. Jason Humananski submitted paperwork to Solicitor Buffalino stating that the judge agreed to refile charges. Bufalino will represent the borough at the hearing.

Jack Davis was also interested in that case and asked who received the letter of notification. He was told that the Borough’s third party received it and is responsible for going to court.

Eugene Monahan asked about cleaning the stream bordering the Harveys Lake Beach Club and about storm drains near that property. He will present paperwork and a meeting with WVSA will be arranged to see if they can tie into existing storm drains. He will also contact DEP about dredging beach area.

Bill Hunsinger asked about Fishing Tournaments at Harveys Lake and can they be required to pay an amusement tax or for a special events permit?

**Reports from Committees:**

**POLICE COMMITTEE:** **Bill Hilburt**, Tom Kehler, Ed Kelly - Mayor Rush reported that there were 159 calls

**GRANTS COMMITTEE:** **Dave Delaney**, Brandon Harris, Clarence Hogan. Dave Delaney reported that they are still looking for grants for the playground project.

**BMCP:** **Clarence Hogan**, Irene Sankey (Alternate) Next meeting April 21, 2022.

**EAC:** **Michell’e Boice**, Dave Delaney – Michell’e Boice reported on the Hydrilla removal grant and that the borough will have to pay half of the fee up front and then get reimbursed.

Brandon Harris made a motion to accept the reports and Tom Kehler seconded it. Motion passed.

Jason Miller gave the EAC Board report. The NFWF grant has been applied for. The steam bordering the Beach Club will be cleaned of debris without uprooting any plants. He will get a permit from DEP. He also gave a report from the PALMS convention.

**NEW BUSINESS:**

**Amendment of Ordinance to prohibit second story boathouses for clarification purposes.**

Tom Kehler made a motion for the solicitor to prepare an amendment to the ordinance which clarifies the prohibition of second stories on boathouses. Michell'e Boice seconded it and the motion passed.

**Spring Cleanup – Change timeframe** - After discussion, Michell'e Boice made a motion to keep the cleanup in the spring for this year. Tom Kehler seconded it and the motion passed.

**Princeton Hydro Hydrilla Abatement** – Tom Kehler moved to table this item and Brandon Harris seconded it. Motion passed.

**Change of Date for May Council Meeting** – After discussion, Tom Kehler made a motion to change the date of the May meeting to Tuesday, May 24, 2022. Ed Kelly seconded the motion and it passed.

**OLD BUSINESS**

**Update on Renovation Project** – Tom Kehler gave a report on the project. The inside work is almost complete but the entrance and canopy will take some additional time.
