I hereby release Angela Bartmess and Cody Bartmess (DBA ALL AMERICAN FLOATS AKA ALL AMERICAN), all other owners, officers and employees of All American Floats of and from any liability for any personal injury or property damage, or from participating in any activity associated with the business of All American Floats, while on the Illinois River, on All American property or anywhere else.

This release expressly includes claims for any injuries or damages, past, present or future, acquired or yet to accrue, that were caused by nature and/or negligence of All American Floats (including business and property owners, employees, etc).

Furthermore, I hereby agree to indemnify and hold harmless Angela Bartmess and Cody Bartmess (DBA All American Floats AKA All American), their heirs and assigns, officers, employees, and any other person, firm or corporation bound to defend or pay judgment's against them, from any and all debts, liens or expenses, as well as any and all claims, demands or causes of action, including claims for contribution or indemnity, and the reasonable and necessary cost, including attorney's fees, incurred in the defense of any such claim, whether for personal injury or property damage, or any other form of damages that might arise.
