- Orders can be made via email, payment for goods and related delivery charges must be made in advance of orders being despatched.
- Orders are subject to a delivery charge; VAT is not applicable.
- Goods purchased for business purposes may not be sold through online marketplaces such as Amazon, Ebay, or similar without our express written consent. Goods may not be altered, re-packaged or re-branded under any circumstances.
- We will not be liable for any failure or delay in performing our obligations where that failure or delay results from any reason beyond our reasonable control.
- We accept the return of goods which are damaged or faulty provided we are notified within 7 days of receipt of order.
- We can only accept returned items if they are returned to us in an unused state. Faulty items will be replaced or refunded once the original item has been received in its original packaging and inspected by us. The buyer is responsible for the cost of postage to return the goods unless the goods are found to be faulty.
