Participant Agreement, Release and Waiver of Liability, and Assumption of Risks

Please read this document carefully before signing. By signing below, you acknowledge and agree to the terms outlined in this Participant Agreement, Release and Waiver of Liability, and Assumption of Risks ("Agreement").

- 1. Understanding and Acknowledgment: I, (Full Name) ______, understand that participating in soccer and related activities organized by Resalat FC or Soccer Club ("Club") involves inherent risks, including but not limited to bodily injury, illness, property damage, and even death. I voluntarily choose to participate and hereby acknowledge that I have carefully read, understood, and agree to all the terms and conditions in this Agreement.
- **2. Assumption of Risks:** I understand and acknowledge that participating in soccer and related activities involves inherent risks and dangers, including but not limited to physical injury, illness, property damage, and even death. I voluntarily assume all such risks and acknowledge that my participation is entirely voluntary.
- **3. Health and Medical Condition:** I confirm that I am in good health and physically capable of participating in the activities organized by the Club. I acknowledge that it is my responsibility to inform the Club's organizers of any pre-existing medical conditions, allergies, or other health-related concerns that may impact my participation.
- **4. Release and Waiver of Liability:** In consideration of being allowed to participate in Club activities, I hereby release, discharge, and hold harmless the Club, its officers, directors, employees, agents, volunteers, sponsors, representatives, and affiliates (collectively referred to as "Released Parties") from any and all claims, liabilities, demands, actions, costs, expenses, or causes of action arising out of or related to any loss, damage, injury, or harm I may sustain during or as a result of my participation, including any claims arising from the negligence of any Released Party or otherwise.
- **5. Indemnification:** I agree to defend, indemnify, and hold harmless the Released Parties from and against any and all claims, liabilities, costs, expenses, or damages, including reasonable attorney's fees, arising from, or related to my participation in Club activities or any breach of this Agreement.
- **6. Use of Likeness:** I grant Resalat FC the right to use, reproduce, and distribute photographs, video footage, and other media of mine taken during Club

activities for promotional and marketing purposes, without compensation or further consent and notice.

- 7. Treatment Consent and Emergency Medical Care: I authorize the Club, its trainers or coaches, management members, and authorized medical personnel to provide immediate medical treatment, including first aid, CPR, and emergency medical care, in the event of an injury or illness during Club activities. I understand that the Club will make reasonable efforts to contact emergency medical services if necessary and that I am responsible for any costs associated with medical treatment.
- **8. Transportation to Medical Facility:** I authorize the Club and its representatives to arrange for my transportation to a medical facility for evaluation and treatment if deemed necessary. I understand that this decision will be made in the best interest of my health and safety.
- **9. Governing Law and Jurisdiction:** This Agreement shall be governed by and construed in accordance with the laws of Missouri. Any legal action or proceeding arising from this Agreement shall be resolved exclusively in the state or federal courts located within Saint Louis County/City, Missouri.
- **10. Entire Agreement:** This Agreement constitutes the entire agreement between the parties and supersedes all prior and contemporaneous agreements, understandings, negotiations, and discussions, whether oral or written.
