New Eagle Borough Council met in regular session on Tuesday, December 6, 2016 at 7:00 PM at the regular meeting place.

Ordinance No. 541 fixing the tax rate for the year 2017 was presented to Council for approval. It was moved by Caseber and seconded by Sherry to approve the Ordinance as presented. Motion was carried by the unanimous call of the roll by the Secretary.

The Council meeting schedule for 2017 was presented to Council for approval. It was moved by Pucel and seconded by Sherry to approve the schedule as presented. Motion was carried by the unanimous call of the roll by the Secretary.

President Fine advised that the Railroad had kept their word and both crossings were repaired.

President Fine advised that he and Mr. Ferguson surveyed Second Avenue for the work that will be done there through the Redevelopment Authority.

Mr. Sherry advised that all of the paving had been completed and the areas that were in need of stone had been taken care of. Also, the trucks, salt spreaders and plows are all ready for the upcoming winter snows.

Solicitor Berggren advised that the Ordinance Books were given to the Secretary and she was to finish indexing each binder.

Chief Tempest advised that the Seat Belt Grant that had been given to the Police resulted in a lot of citations in New Eagle. He also advised that the 7-11 had been recently robbed.

There being no other business, it was moved by Caseber and seconded by Sherry to adjourn at 7:21 PM. Motion was carried.
