A motion was presented to Council to appoint Mr. J. Ferguson as the Board Member Representative of the Monongahela Area Chamber of Commerce for New Eagle Borough. It was moved by Pucell and seconded by Caseber to appoint Mr. Ferguson. Motion was adopted by the vote of the following members of Council: A. Caseber, J. Fine, O. Pucell and W. Sherry. Mr. J. Ferguson abstained. Mayor Fine extended a Thank You to New Eagle Borough for the donation towards the treat bags for the Santa Fund. He advised that approximately 300 treat bags were delivered to the children of the Borough.

Solicitor Berggren advised that he will be scheduling a meeting with Council to review the final Ordinance Books as soon as he receives them.
