J. Miller Department Supervisor for Public Works gave report on work done in the past month. Several stop signs have been replaced. Tar buggy was repaired. Debris and garbage removed from Main Street. They continue to cut grass weekly. He would also like Council to consider installing a camera system at the Public Works garage. The condition of the Chevy Colorado is getting worse, he asked Council if they would consider purchasing a ¾ ton truck with a plow. The current truck is unable to transport heavy equipment. Council agreed to look into this.

Solicitor T. Berrgren that the police contract has been revised. A five-year reopening clause has been added to the contract. He also researched the unopen portion of Marion Street next to resident Richard Charlton property. Mr. Charlton my petition Council to vacate the Street. Both property owners adjacent to the Street would have to agree to vacate.

New Business: Council would like to put a fee on additional rental inspections when the property fails the first time. Solicitor T. Berrgren will put together the Resolution.
