

### SHARONA Studbook Categories:

The following table gives a simplified overview of the Studbook categories. NASS-registered horses are placed into a Studbook when they are presented for inspection for Breeding Approval. The horse's performance record can also be taken into account as a significant element of the Breeding Approval process. Subsequent successful completion of the NASS Stallion Performance Test is also a requirement for Book I stallions.

<b>Stallion Book I (Main Stallion Book)</b>	<p><b>Must be registered as:</b> Purebred Shagya-Arabian Book I per NASS definition.</p> <p>Achieves average score of 7 or above, with a 7 or above for type and no score under 5.</p> <p>For permanent status in Stallion Book I, must meet NASS stallion performance requirement within the given time frame. (see NASS Stallion Performance Requirements for detailed information)</p>
<b>Appendix to Stallion Book I (Appendix to Main Stallion Book)</b>	<p><b>Must be registered as:</b> Purebred Arabian, or Appendix Shagya-Arabian (P-ShA).</p> <p>Achieves an average score of 8 or above, with an 8 or above for type and with no score under 5.</p> <p>For permanent status in Book I Appendix, must meet NASS stallion performance requirement within the given time frame. (see NASS Stallion Performance Requirements for detailed information)</p> <p>Must submit negative SCID test.</p> <p>OR</p> <p>If stallion presented has already met the equivalent of a NASS performance requirement, the stallion must achieve an average score of 7 or above, with a 7 or above for type and with no score under 5.</p> <p>Must submit negative SCID test.</p>
<b>Stallion Book II (Stallion Book)</b>	<p><b>Must be registered as:</b> Purebred Shagya-Arabian or Shagya-Arabian (ShA) or Appendix Shagya-Arabian (P-ShA) per NASS definition and meets 9/16 rule.</p> <p>Does not meet minimum scores (as described for Books I above), and/or does not meet stallion performance requirement.</p>
<b>Appendix to Stallion Book II (Appendix to Stallion Book)</b>	<p><b>Must be registered as:</b> Purebred Arabian or Appendix Shagya-Arabian(P-ShA) and does not meet 9/16 rule.</p> <p>Does not meet minimum scores as listed in Appendix to Stallion Book I and/or does not meet stallion performance requirement.</p>

<p><b>Mare Book I (Main Mare Book)</b></p>	<p><b>If registered as:</b> Purebred Shagya-Arabian Book I per NASS definition.</p> <p>Achieves an average score of 6 or above, with no score under 5.</p> <p>OR</p> <p><b>If registered as:</b> Shagya-Arabian (ShA) or Appendix Shagya-Arabian (P-ShA) AND meets 9/16 rule.</p> <p>Achieves a minimum average score of 7 with no score under 5.</p> <p>OR</p> <p>If the mare presented has already successfully completed the equivalent of the NASS stallion performance requirement, the mare must achieve an average score of 6 or above with no score under 5.</p>
<p><b>Appendix to Mare Book I (Appendix to Main Mare Book)</b></p>	<p><b>Must be registered as:</b> Appendix Shagya-Arabian (P-ShA) or Purebred Arabian.</p> <p>Does not meet 9/16 rule.</p> <p>Achieves an average score of 7 or above and no score under 5.</p> <p>OR</p> <p>If mare presented has already successfully completed the equivalent of NASS stallion performance test, the mare must achieve an average score of 6 and no score under 5.</p>
<p><b>Mare Book II (Mare Book)</b></p>	<p><b>Must be registered as:</b> Purebred Shagya-Arabian Book I.</p> <p>Does not achieve minimum scores as described above for mare Book I.</p> <p>OR</p> <p><b>If registered as:</b> Shagya-Arabian.</p> <p>Does not achieve qualifying scores as described above For Mare Book I.</p>
<p><b>Appendix to Mare Book II</b></p>	<p><b>Registered as:</b> Appendix Shagya (P-ShA) or Purebred Arabian.</p> <p>Does not achieve qualifying scores as described above for Appendix Mare to Book I</p>
