Breeding Committee Report 1-22-23

There have been no requests for inspections, things have been pretty quiet.

Saturday I gave a talk to the Trakehner Association of America at their meeting in Buckeye Arizona. Kathy Richkind assisted me. I had been asked to talk about the Shagya Arabians, the history of NASS, and the connection between Shagya Arabians and Trakehners. There were about 30 attendees. I made up an 18 page handout with a map of historical breeding farms as well as pedigrees of some of the Purebred Arabians and Shaqya-Arabians that have been used in their breed, along with photo examples of the major types—Shagya, O'Bajan, Gazal, and Koheilan, and related these back to the Shagya-bred horses which have contributed to the Shagya breed. I also included the two-part article on the Polish Arabian lines in Bravo's pedigree since many of those Polish lines exist in Trakehner pedigrees also. I added a NASS brochure to every packet as The talk was only an hour, so I couldn't cover everything, but people well. seemed to find it interesting. Shelley Child also presented a mare which was approved as well.
