The ISG is proposing a new rule that any purebred Arabian mare or stallion must have the sire line that already exists in the breed. Exceptions can be made if approved by the ISG BOD. Adele will put a report together to take with her to Bábolna. Adele has been invited to judge at the Show. Kathy is also going.

Also, Rob Sawyer in Connecticut, with a part-Shagya-Arabian, and Skye Pechie in Rhode Island, want their horses inspected and Skye has a Wineglass mare. **Promotions Committee/BRAVO AWARD:** Candace Phillips, Chairman – Hallie Goetz made a nomination for the mare MGL Olivia for the Bravo Award. “She is a wonderful example of the versatility, endurance and longevity of our Shagya-Arabian. She has proven herself under saddle in AERC and other competitions for 6-plus years, being just shy of 5000 recorded AERC miles. She produced the stallion MCV Ohrmidas who is approved for breeding with NASS and who has competed successfully as a ½ Arabian Sport Horse. Olivia and her offspring are great ambassadors for the breed. They have also participated in the NASS Performance Awards Program.” To be discussed by the committee and brought to the next meeting.

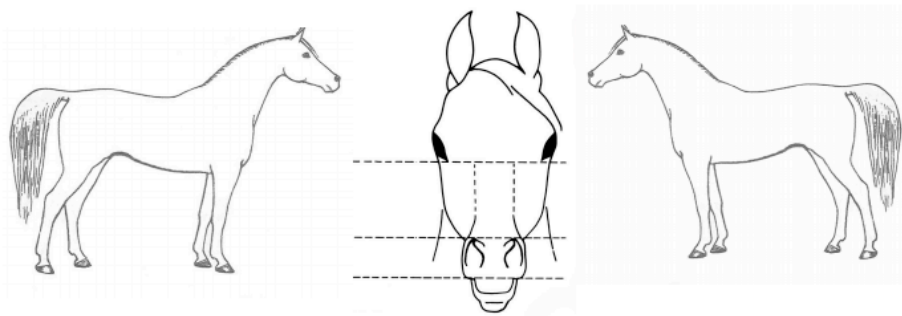
