## **REGISTRAR'S PROCEDURES**

The Branding Agent will mail via registered mail the original completed application to the Registrar who upon receiving the application will see whether the brand has been noted on the horses' papers by the Branding Agent. If this has occurred, the application will be filled immediately in the horses' permanent records.

A branding application that shows the brand has not been noted on the horses' papers because the horse is not yet registered or is being sold on contract, a separate pending file of the original branding application will be maintained.

When the papers are transferred to the new owner for the branded horse sold on contract, the new owner will send the registration papers to the Registrar. The Registrar will note the pertinent branding information, send one copy of the papers to the NASS Breeding Committee Chair and return the papers to the new owner. The Registrar will then re-file the branding application from the pending file to the horses' permanent registration file.

When branded non-papered horses' registrations are completed the Registrar will note the pertinent branding information on the registration papers. The Registrar will then re-file the branding application from the pending file to the horses' permanent registration file.
