All exhibitors that are showing and/or selling an animal through the Dairy or Jr. Livestock Sale are required to be present in the arena at the time of the show and sale. Violations of this rule will result in the following:

- 1) A penalty-fee deduction of 25% from the net sale price of the animal
- 2) A one (1) year suspension from all activities (including showing and selling of animals, etc.) at the Kings Fair for each offending exhibitor.
- 3) Member must show and sell own animal during the Kings Fair. (Please note: only exception to rule is if a member has two or more animals in the same class or for medical reasons APPROVED BY FAIR MANAGER)

I will abide by the rules and regulations concerning market animals in the Exhibitor's Handbook for The Kings Fair. By signing this contract, I promise to be bound by these rules.
