## 2018 HIGHLIGHTS

2018 proved to be a very challenging year. West Side Improvement Project. Starting with the presentation of the condition of our roads by WSN at the annual meeting in March of 2017. The board with the help of a number of residents started a five year plan for repair and improvement of the township roads. A preliminary plan was presented by members of the planning committee with input from Tim Schoonhoven, with WSN. It was recommended, to be proactive, we should make repairs sooner than later. This plan was presented in late December of 2017. The committee returned to the January meeting with a revised plan for progressing with needed maintenance, rebuilding and blacktopping. The proposal was presented with estimated construction costs. The cost included bonding \$2.5 million in 2018 to make repairs needed by the recommendation of the WSN comprehensive study. This also included the upgrade of some of the gravel roads to prepare for blacktopping. Also bonding in 2019 was discussed for more improvements on the west side of Lake Ida. At the February meeting, discussion listed different projects for the coming summer. 1. Repair current blacktop where needed. 2. Rebuild gavel roads where needed for blacktopping. 3. Blacktop Oak Ridge Lane, south end of Oak Ridge Road, Omaha Lane, and Little Ida Beach Road. The Annual Meeting brought about a lot of discussion about the proposed road projects and the money we need to borrow to complete the work. At the March meeting, the board was presented with better estimated costs of the West Side Improvement Project. Discussion was deferred to the April meeting when all the board would be present.

In April, a motion was made and passed to bond for \$2.3 million. The board then decided to let bids for the repair of 10.8 miles of road that were in dire need of repair. A decision was made to go with public bonding to save some money. At the May meeting, Resolution

18-06 ordering improvements and Resolution 18-07 approving advertising of bids for the West Side Improvements were passed. At the June meeting, bids were opened resulting in awarding Central Specialties the bid of \$1,140,136.50 for 10.8 miles of repair work. Clerk/Treasurer, Barb Kilgore reported that the total amount needed for Phase 1 including the change order for the extra blacktopping including engineering costs would need a bond for \$2,195,000. A June 26th preconstruction meeting got the project started. At the July meeting, the board was informed the bonding went so well we received a lower interest rate than anticipated. At the August meeting, WSN let us know there are some wetland issues that need to be addressed in Phase 2 of the project for 2019. This consists of 3.8 miles of road in the Water Lily Trail, Shady Haven, Circle drive and Memory Lane area. September brought Phase 1 closer to being complete. We also paid CSI the final payment except for the 5% retainage. WSN is working on construction easements for Phase 2. November marked CSI finishing the checklist for the completion of Phase1. December, WSN got the bid numbers together for Phase 2 to be reviewed in January. Wetland information was proceeding with Jerry Haggenmiller of Douglas County Soil & Water.

**Other Road Highlights.** Graveling, maintenance, (blading etc.) and lawn mowing bids were accepted in April. On May 14th, the board did their annual road review. In June, the board accepted bids for sealcoating Burkeys Lane, Maple Circle, and Sunset Strip north of 61. Barb has also been working on getting the turnarounds recorded with the County Recorder that were not done in the past.

I would like to thank everyone for their work and comments through the year. Your feedback and comments make my job easier. Thank you for allowing me to work for you!

## **NOXIOUS WEEDS**

One of the duties of a township supervisor, each spring, is to patrol the township road ditches, vacant lots and farm fields for weeds that are on the state of Minnesota Noxious Weed List. Ida Township seems to have

an abundance of Canadian Thistles. Wild Parsnip was also found in the township. Pictures of the weeds can be found on the MN website DNR http://www.dnr.

state.mn.us/plants-insects/minnesota-noxious-weedlist. Once there you will see a box on the right side for the 2019 Noxious Weed List. If you click on that a list of all the weeds will pop up. If you click on one of the 42 plants on that list you will be able to see information about that weed and pictures to help you identify that weed.

Please take some time to look for these weeds and either spray or cut them. If you do this, we the board, will not have to send you a letter asking you to take this action. If issues are not addressed, after notification, the board will hire someone to get rid of the weeds and then bill you for the work. If we all work together on this issue, the noxious weeds will be taken care of and "OUR" township will benefit by this combined efforts. Thanks for your help!
