The Town Board of Ida Township, Douglas County, Minnesota holds its regularly scheduled board meetings on the Third Monday at 6:00 pm, at the Ida Township Hall at 4700 County Road 6 NW, Garfield, MN.

A quorum or more of the Town Board may also attend the Douglas County Board of Adjustments and Planning Advisory Commission Meetings regularly held on the first and third Tuesdays of the month starting at 6:00 pm and are held at the Douglas County Courthouse, 305 8<sup>th</sup> Avenue West, Alexandria, MN.

A quorum or more of the Town Board may also attend the Douglas County Commissioners Meetings regularly held on the first four Tuesdays of each month starting at 9:00 am and are held at the Douglas County Courthouse, 305 8<sup>th</sup> Avenue West, Alexandria, MN.

A quorum or more of the Town Board may also attend the Douglas County Development Review Team Meetings that are held on the second and fourth Tuesdays of the month starting at 2:00 pm and are held at the Douglas County Courthouse, 305 8<sup>th</sup> Avenue West, Alexandria, MN.

A quorum or more of the Town Board may also attend pre-viewings set up by Douglas County Land and Resource Management. The pre-viewings are held on Friday mornings starting at 9:00 AM and are held at the on-site location of properties in Ida Township, where the property owners are requesting variances or conditional use permits.

A quorum or more of the Town Board may also attend the Douglas County Weed Inspectors meeting and the Douglas County Association of Township meeting held on the third Wednesday in March each year.

If the date of a regular Town Board Meeting falls on a holiday or conflicts with an election, the meeting will be held the following day at the same time and place. If a regular Town Board Meeting must be held at a different date, time or place than indicated above, or if the Town Board decides to hold a Special Board Meeting, notice of the meeting will be posted at the following public posting places designated by the Town Board:
