#### **2019 HIGHLIGHTS**

The past year proved to be as challenging as 2018. With the proposed road work to be done this year the board started with securing another bond for \$1,250,000.00. Then the board let bids for the rebuilding and blacktopping 3.8 miles to complete West side Improvements Phase 2. After rebuilding the base the wet weather forced a decision to install the base layer of blacktop earlier than planned. We then did the wear layer later in the fall. The work has been completed except for some final grading and landscaping. We also installed school bus stop and

speed limit signs on Big Chip trail. The interesting part is that someone decided to remove the speed limit signs so we had to replace them. I would also like to mention that we continue to have to pick up trash such as sofas, tires, boxes of trash and other things out of the side of the roads. Please realize that this becomes a cost for the township. If you have any concerns with township workings, please feel free to attend any meeting and voice your concerns. Your input makes it easier for the board to make decisions. Once again thank you for your support.

## **NOXIOUS WEEDS**

One of the duties of a township supervisor, each spring, is to patrol the township road ditches, vacant lots and farm fields for weeds that are on the state of Minnesota Noxious Weed List. Ida Township seems to have an abundance of Canadian Thistles. Wild Parsnip was also found in the township. Pictures of the weeds can be found on the MN DNR website http://www.dnr.state.mn.us/plants-insects/minnesota-noxious-weed-list. Once there, you will see a box on the right side for the 2020 Noxious

Weed List. If you click on that a list of all the weeds will pop up. If you click on one of the 42 plants on that list, you will be able to see information about that weed and pictures to help you identify that weed.

Please take some time to look for these weeds and either spray or cut them. If you do this, we the board, will not have to send you a letter asking you to take this action. If issues are not addressed, after notification, the board will hire someone to get rid of the weeds and then bill you for the work. If we all work together on this issue, the noxious weeds will be taken care of and "OUR" township will benefit by this combined effort. Thanks for your help!

### **2020 CENSUS**

Census 2020

Every ten years the United States counts its residents. The next count is this year. April 1st is Census Day. In mid-March you will receive a letter in the mail inviting you to respond to the 2020 census. You can respond to the short questionnaire online, by mail or by phone. Douglas County asks that you participate to make sure Minnesota receives its maximum amount of federal dollars (\$2,796 per Minnesotan), we retain all 8 congressional seats, and can plan for roads, hospitals, schools and future businesses. In the last census, Ida Township had

an 85% response rate. Congratulations to all that participated. The goal for 2020 is at least a 90% response rate. Your response is confidential and should only take a few minutes. # **IDA TOWNSHIP HISTORICAL NOTE**

Published in the Alex Post News. Friday March 24, 1876, p 4:

A Big Slide on the Ice. Mr. E. H. Alden is moving his dwelling house and mill from the upper end of Lake Miltona down to the outlet of Lake Ida. The distance is eight miles, nearly all the way on the ice of the two lakes. The dwelling will be moved entire; the mill will be taken apart, and re-built on the Long Prairie River, between Lakes Ida and Charlie and about five miles from Alexandria.
