Pleasant Grove Tree Removal. RBS removed the trees on Pleasant Grove between 8tst Avenue and Buckskin Lane. They will go back and grind the stumps.

Wahtomin Trail Speed Bumps. Greg Stehn addressed the Board regarding the speed bumps that were put on Wahtomin Trail last year to slow down traffic. Mr. Stehn is against putting the speed bumps back this summer. Diedrich informed him that the Board is looking into alternatives such as less aggressive speed bumps or putting in a crosswalk with warning signs.

Pilgrim Point Shores Development. Diedrich reported that he along with Peterson attended a meeting with the County regarding the Pilgrim Point Shores Development. The County will be taking over Pilgrim Point Road and making it a County Road. The developer will put in some roads for the 29 planned lots and
