**Big Horn Bay Road Project.** Kilgore provided an estimate of the number of parcels that will be assessed for the paving project. There are an estimated six parcels located in Leaf Valley Township and 85-90 located in Ida Township. Diedrich will provide the estimated amounts to the Leaf Valley Town Board. Based on the feasibility study, Ida Township would be assessed approximately \$5,000 per parcel for the Ida Township portion of the project. If we include the north section of Big Horn Bay Road that extends into Leaf Valley, the Ida Township assessments would increase to approximately \$6,000 per parcel.
