Big Horn Bay Road Project. Diedrich made the following corrections to the estimated assessment amounts that were given at the March 2, 2020 town board meeting. The estimated per parcel assessment for Ida Township parcels in the project area are \$2,661 per parcel for the Ida Township portion of the project and an additional \$1,258 per parcel would be added if the project includes the north section of Big Horn Bay Road located in Leaf Valley. Diedrich noted that these assessment amounts are only estimates and the actual amounts could vary between 10 and 15 percent. Diedrich spoke with a Leaf Valley Town Board member and they would require a service district be set up for the Leaf Valley section
