

Minutes
Ida Township Board Meeting
May 3, 2021

The meeting was called to order at 7:30 p.m. by Chairman Dan Diedrich. Supervisors Jeff Way and Mike Steidl and Clerk/Treasurer Barbara Kilgore were also present.

Diedrich announced that the recorder being used to record the meeting belongs to the clerk and is only used to assist her in taking the minutes of the meeting.

Minutes

April 19, 2021 Town Board Meeting. Steidl made the motion to approve the minutes of the April 19, 2021 Town Board Meeting as written. Way seconded the motion. Motion carried. Diedrich-aye, Way-aye, Steidl-aye.

Roads

Diedrich reported that we had a good Road Review this morning.

Oakwood Terrace Turn-around. Kilgore informed the Board that the Township Attorney will be meeting with the Koewlers to have the easement for the turnaround signed on May 6, 2021. The attorney will have the document recorded with Douglas County .

Gravel. Steidl made the motion to approve 172 loads of gravel as noted on the Road Review Gravel Map plus an additional 30 loads as needed throughout the season. Way seconded the motion. Motion carried. Diedrich-aye, Way-aye, Steidl-aye.

Old Business

Developers' Agreement. Issue tabled until more information is obtained.

Resolution 21-04 Wages & Compensation. Diedrich made the motion to adopt Resolution 21-04 setting the wages & compensation for the Town Board effective May 1, 2021. Steidl seconded the motion. Motion carried. Diedrich-aye, Way-aye, Steidl-aye.

Sign Agreements. The Board signed the agreements with the Contractors for road maintenance, gravel, and mowing.

Weed Spraying Town Hall Property. Two quotes were obtained for spraying the town hall property for one spring application for weeds. TruGreen - \$512.51, Biobuilders - \$486.54. Diedrich made the motion to have Biobuilders spray the town hall property for one spring application. Steidl seconded the motion. Motion carried. Diedrich-aye, Way-aye, Steidl-aye.

New Business

Local Board of Appeal and Equalization. The Board reviewed the adjustments in property value that were made at the open book County Board of Appeal and Equalization. The Board will look into how the Township can take back that meeting.

Mail and Permits.

The mail and permits were reviewed by the Supervisors.

Public Comment Frank Bartlett asked about the process for petitioning to have Sahara Lane blacktopped. The Township would like to have a turnaround constructed if the road is to be blacktopped. Kilgore will give Bartlett a blank petition.

Adjourn. Steidl made the motion to adjourn at 8:13 p.m. Way seconded the motion. Motion carried. Diedrich-aye, Way-aye, Steidl-aye.
