The meeting was called to order at 7:30 p.m. by Chairman Dan Diedrich. Supervisors Mike Steidl and Jeff Way and Clerk/Treasurer Barbara Kilgore were also present.

Minutes

Treasurer's Report

April 2021 Treasurer's Report. Diedrich made the motion to approve the April 2021 Treasurer's Report as written and presented. Way seconded the motion. Motion carried. Diedrich-aye, Steidl-aye, Way-aye.

Review & Pay Bills.

Steidl made the motion to approve and pay the bills and to approve the following operating transfer. Way seconded the motion. Motion carried. Diedrich-aye, Steidl-aye, Way-aye.

- Transfer \$51,868.07 from Bremer Money Market to Bremer Checking to cover checks written.

Kilgore made the transfer from the Bremer Money Market Account with check 802 and paid the bills with checks 10894-10910 from the Bremer Checking Account. PERA was paid electronically with SOMPER000604326.

Roads

Diedrich reported that the graveling is just about done. He did note a few more spots where gravel was needed.

Soft Spots. There are four soft spots that need to be dug out two feet down, matting put in place and covered with 18 inches of granular fill and 6 inches of class 5 gravel. They are located on the intersection of Blue Jay Way and Utopia, Blue Jay Way by 9401, Pleasant Grove by 4141 and Sunset Strip south. Diedrich measured a total of 900 linear feet by 22 feet wide. Diedrich will obtain four quotes for doing the repairs.

39th Avenue Tree Trimming. There are a couple of large willows and a few smaller trees on 39th Avenue that need to be removed. RBS Excavating will remove them.

Oakridge Road. There were two boring holes in the blacktop on Oakridge Road that had washed out underneath. RBS filled them in and packed them down.

81st Avenue. Randy Becker a property owner on 81st Avenue would like to put in an approach to his property when the planned upgrades to 81st Avenue are being made. Diedrich said to watch for the contractors to begin working on the road and let them know where he wants his approach installed.

Old Business

Developers' Agreement. Diedrich is going to meet with Dave Rush, Douglas County Land & Resources about the agreement. Issue tabled until more information is obtained.

New Business

Certificate of Right to Burial # 27. Way made the motion to approve Certificate of Right to Burial # 27, Block two, Lots 22 & 23 to Grantees Josh & Ellen Jorissen at the Lake Charley Cemetery.

Petition to receive Township Pricing at Lake Charley Cemetery. Way made the motion to grant the petition for township pricing for a lot in Lake Charley Cemetery from John and Carla Nienabor. Steidl seconded the motion. Motion carried. Diedrich-aye, Way-aye, Steidl-aye.

Town Hall. Way made the motion to open the town hall rental and meeting usage to full capacity and remove the mask mandate. Steidl seconded the motion. Motion carried. Diedrich-aye, Way-aye, Steidl-aye.
