The meeting was called to order at 7:30 p.m. by Chairman Dan Diedrich. Supervisor Jim Peterson and Clerk/Treasurer Barbara Kilgore were also present at the meeting. Supervisor Mike Steidl was absent.

Minutes

May 18, 2020 Town Board Meeting. Diedrich made the motion to approve the minutes of the May 18, 2020 Town Board Meeting as written. Peterson seconded the motion. Motion carried. Diedrich-aye, Peterson-aye.

Roads

Road Report.

Diedrich reported that there are soft spots showing up on some of the gravel roads. Okerlund Graveling will start putting the gravel down on roads noted on the Road Review on Tuesday, June 2, 2020. The chloride will be here on Wednesday, June 3, 2020.

81st Avenue West of County Rd 6. Township Engineer, Stabnow, will have quotes for repairing 81st Avenue between County Road 6 and Pleasant Grove available at the June 15, 2020 Town Board Meeting.

81st Avenue, Lake Ida Way Tile. Stoeckel-Jahner Surveyors will be working on a development in the area and will have the tile installed along 81st Avenue to Lake Ida Way.

Highland Circle. Stoeckel-Jahner Surveyors will also survey the northwest corner of Highland Circle to confirm where the road is supposed to be located.

Wahtomin Trail Speed Bumps. The Board has received numerous complaints about the speed bumps that were installed on Wahtomin Trail by the Chippewa Trails Association. The people at the association like having the speed bumps there for safety. The Board decided to leave the speed bumps in place for the summer months and have them removed in the fall. The Board will investigate other options for slowing traffic down in the future.

Big Horn Bay Road Project. Diedrich is still working with Leaf Valley Township on getting an agreement for the project.

Old Business

2019 Audit Management Letter. Diedrich signed the 2019 Audit Management Letter, completing the 2019 Audit with Carlson SV Auditors.

New Business

Lake Charley Cemetery. Peterson made the motion to hire Greg Cabana as the caretaker of the Lake Charley Cemetery at a salary of \$1500. Per year effective June 15, 2020. Diedrich seconded the motion. Motion carried. Diedrich-aye, Peterson-aye. Mr. Cabana will submit some of his plans for the cemetery

at the June 15, 2020. Mr. Cabana will provide the labor for the projects. Diedrich will have Tower Hills clean up the leaves on the lower level of the cemetery.

Census 2020 Training. Nicole Lemasurier asked if she could use the Ida Township Hall for training for the 2020 Census and would like to use the Township's Wifi. The Supervisors said she can use the town hall for training but cannot use the township's Wifi.

Mail & Permits. Mail and permits were reviewed by the Supervisors.
