Drake Herd, Kevin Weber. Mr. Herd and Mr. Weber expressed their concerns about a recent County meeting regarding the Pilgrim Point Shores Development Project. They did not feel their interests were represented by Diedrich at the meeting. Diedrich said he attended the meeting to obtain information on the Environmental Worksheet that the County is doing on the project and tries to do what is in the best interest of the entire township.
