Minutes

Roads

Road Report.

Diedrich reported that he had gravel put on Cottontail Lane, Burr Oak Drive and Aldrich Road. RBS is blading all of the gravel roads getting them in shape for winter.

Big Horn Bay Road Project.

- **Leaf Valley Agreement and Waiver.** Peterson made the motion to sign the agreement with Leaf Valley Township regarding the section of Big Horn Bay Road that is located in Leaf Valley Township. Steidl seconded the motion. Motion carried. Diedrich-aye, Peterson-aye, Steidl-aye.
- **Digital Speed Monitor sign.** Diedrich ordered a Digital Speed Monitor from Douglas County. The County will install it. It is estimated to cost \$3,500-\$4,000.

Wahtomin Trail Speed Bumps. Diedrich will have RBS remove the speed bumps on Wahtomin Trail for the winter.

81st Avenue Drainage. Diedrich was informed by Township Engineer, Jeff Stabnow that since Gardonville Telephone has put fiber optic cables in the ditch along 81st Avenue, the developer has put in a storm water ditch that will direct the water into Lake Ida instead of putting a tile in.

ALASD Report. Glenn Van Amber, our representative on the ALASD Board, reported to the Board that the MPCA has granted ALASD a variance in the amount of chloride allowed in its discharge as it is too cost prohibitive to meet the levels allowed. ALASD is to maintain the current levels and it will be reviewed again in five years.
